RE: Memorialization of HR 5682, the Patsy T. Mink Gender Equity in Education Act of 2016 and its Senate Companion Bill S3147, To Support Educational Entities in Fully Implementing Title IX and Reducing and Preventing Sex Discrimination in all areas of Education.

Honorable Legislators:

The late Patsy T. Mink was one of the principal authors of Title IX when it was introduced in 1972. Title IX prohibits discrimination on the basis of gender sex in federally funded educational programs and activities. While Title IX ensures equal opportunities to participate in athletics, technical education and the fields of Science, Technology, Engineering and Math (STEM), girls and women lag far behind male participation rates.

Women continue to be underrepresented in non-traditional fields making up more than 70 percent of students enrolled in low paying and historically traditional female jobs such as caregiving and cosmetology and only 20 percent enroll in classes that prepare students for high-paying and historically male jobs, such as energy technicians and electricians. The National Student Clearinghouse reports that the percentage of women earning STEM degrees has decreased over the past ten years, with women earning 19 percent of engineering bachelor's degrees, 18 percent of computing bachelor's degrees, 42 percent of mathematics bachelor's degrees and 39 percent of physical science bachelor's degrees. Women of color earned only 6 percent of computing bachelor's degrees and 3 percent of engineering bachelor's degrees in 2013.

Gender bias continues to influence every segment of our society. The intent of Title IX is not being realized as envisioned by Congresswoman Mink. That intent includes ensuring that all women are given equal opportunities in education in order to become successful. This Act will provide resources, training and technical assistance to fully implement Title IX, reducing and preventing sex discrimination in all areas of education.

These include:

- Establishing an Office of Gender Equity in the U.S. Department of Education to coordinate activities within and among other federal agencies.
- Combat discrimination, harassment, bias and violence based on sexual orientation, gender, gender identity, pregnancy, childbirth and related medical conditions.
- Support Title IX coordinators with annual training.
- Provide competitive grants to K-12 schools, institutions of higher education, local educational agencies, or states as the primary applicants with the option to partner with organizations with relevant expertise.
- Include evaluation and assessment of how applicants improve on indicators of gender equity.
- Disseminate resources and best practices nationwide.

Therefore, I urge you to join us in memorializing the U.S. Congress in the passage of H.R. 5682, and its companion bill, S3147 and President Obama to sign the Patsy Mink Gender Equity in Education Act.





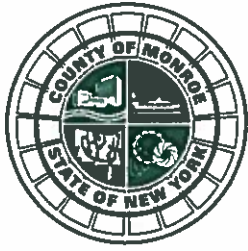

Subject: Acceptance of a Grant from the New York State Division of Criminal Justice Services for the Local Reentry Coordination and Services Program and Authorize a Contract with Delphi Drug and Alcohol Council, Inc.

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the New York State Division of Criminal Justice Services (NYSDCJS), in the amount of \$88,320, and authorize a contract with Delphi Drug and Alcohol Council, Inc., in the amount of \$88,320, for the Local Reentry Coordination and Services Program, for the period of July 1, 2016 through September 30, 2016.

The Local Reentry Task Force (Task Force), which is co-chaired by the County's Chief Probation Officer and includes members from over 40 local law enforcement agencies and human services providers, has a goal of reducing recidivism through improved coordination among criminal justice, social services, educational, health, and mental health systems. The Task Force is addressing the following four reintegration issues of parolees: basic education, employment, sobriety support, and housing. This grant will fund a contract with Delphi Drug and Alcohol Council, Inc. (Delphi) for a Local Reentry Coordinator and also the provision of services related to these reintegration issues. This is the eleventh year of grant funding for this program. The funding for this three-month grant represents 25% of the twelve month grant awarded last year. Subsequent to this grant period, NYSDCJS will resume the grant on a twelve month basis, with grant periods commencing on October 1 of each year.

Delphi is a community-based behavioral health agency serving the Finger Lakes community. Delphi provides a drug and alcohol outpatient program, two domestic violence programs, and case management to clients in specialized courts and both local Home Health initiatives. With its capacity and experience, Delphi will provide a Local Reentry Coordinator and case managers to facilitate obtaining services for approximately 111 parole re-entry participants. Delphi will also obtain temporary housing for these participants as needed.

A request for qualifications was issued and Delphi Drug and Alcohol Council, Inc. was rated the most qualified to provide this service.

The specific legislative actions required are:

1. Authorize the County Executive, or her designee, to accept an \$88,320 grant from, and to execute a contract and any amendments thereto with, the New York State Division of Criminal Justice Services, for the Local Reentry Coordination and Services Program, for the period of July 1, 2016 through September 30, 2016.

2. Amend the 2016 operating grant budget of the Department of Public Safety, Office of Probation and Community Corrections, by appropriating the sum of \$88,320 into fund 9300, funds center 2403010000, Probation Administration.
3. Authorize the County Executive, or her designee, to execute a contract, and any amendments thereto, with Delphi Drug and Alcohol Council, Inc., 727 St. Paul Street, Rochester, New York 14605, for coordination and provision of the Local Reentry services, in the amount of \$88,320 for the period of July 1, 2016 through September 30, 2016.
4. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within grant guidelines to meet contractual commitments.
5. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. This grant is 100% funded by the New York State Division of Criminal Justice Services. No additional net County support is required in the current Monroe County budget.

Delphi Drug and Alcohol Council, Inc. is a not-for-profit agency, and the records in the Office of the Monroe County Treasurer have indicated that it does not owe any delinquent Monroe County property taxes.

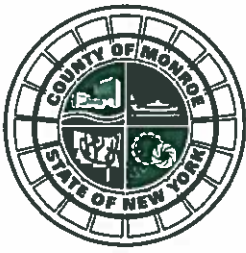

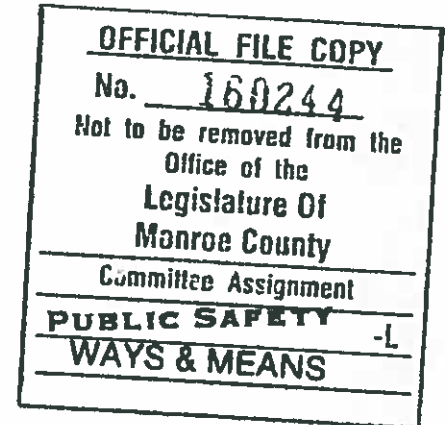

Subject: Acceptance of a Grant from the New York State Division of Criminal Justice Services for the 2016-2017 Aid to Crime Laboratories Program (Monroe County Crime Laboratory)

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the New York State Division of Criminal Justice Services, in the amount of \$668,250 for the 2016-2017 Aid to Crime Laboratories Program, for the period of July 1, 2016 through June 30, 2017.

This grant will enable the Monroe County Crime Laboratory, which serves Monroe County and seven (7) surrounding counties, to reimburse the payroll and fringe benefits for eight (8) existing positions within the Monroe County Crime Lab. Funding will supplement the Laboratory's operational budget for supplies, software, equipment, and expenses related to the continued accreditation of the Laboratory. This is the tenth year the County has received this grant. This year's funding represents an increase of \$37,619 from last year.

The specific legislative actions required are:

1. Authorize the County Executive, or her designee, to accept a \$668,250 grant from, and to execute a contract and any amendments thereto with, the New York State Division of Criminal Justice Services, for the 2016-2017 Aid to Crime Laboratories Program, for the period of July 1, 2016 through June 30, 2017.
2. Amend the 2016 operating grant budget of the Department of Public Safety by appropriating the sum of \$352,925 into fund 9300, funds center 2408040100, Monroe County Crime Laboratory.
3. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within grant guidelines to meet contractual commitments.

4. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law, and when applicable, the terms of any labor agreement affecting such positions.

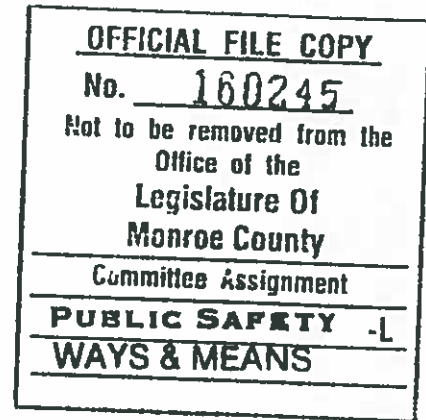

Subject: Acceptance of a Grant from the New York State Division of Homeland Security and Emergency Services for the Reimbursement of FY2016 Emergency Management Performance Grant

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the New York State Division of Homeland Security and Emergency Services, in the amount of \$283,822, for reimbursement of County expenses related to the FY2016 Emergency Management Performance Grant (EMPG), for the period of October 1, 2015 through September 30, 2017.

This grant provides funding for necessary direction, coordination, guidance and assistance, as authorized in Title VI of the Stafford Act so that a comprehensive emergency preparedness system exists in Monroe County. The FY2016 EMPG supports all core capabilities in the prevention, protection, mitigation, response, and recovery mission areas based on allowable costs. This funding partially reimburses the salary and fringe benefits for one (1) Office of Emergency Management (OEM) position, and allows OEM staff to administer mandated reports, equipment inventory, fiscal reporting, planning activities, training activities and exercises.

This grant provides 50% reimbursement for eligible expenses in support of the program. This will be the 25th year the County has received this grant. This year's funding represents a decrease of \$1,248 from last year.

The specific legislative actions required are:

1. Authorize the County Executive, or her designee, to accept a \$283,822 grant from, and to execute a contract and any amendments thereto with, the New York State Division of Homeland Security and Emergency Services, for reimbursement of County expenses related to the FY2016 Emergency Management Performance Grant, for the period of October 1, 2015 through September 30, 2017.

2. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements and to make any necessary funding modifications within grant guidelines to meet contractual requirements.
3. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law and, when applicable, the terms of any labor agreement affecting such positions.

Environmental assessments were completed for this action and it was determined there would be no significant effect on the environment.

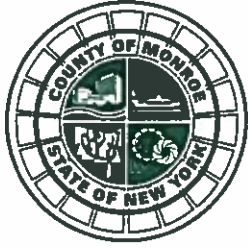

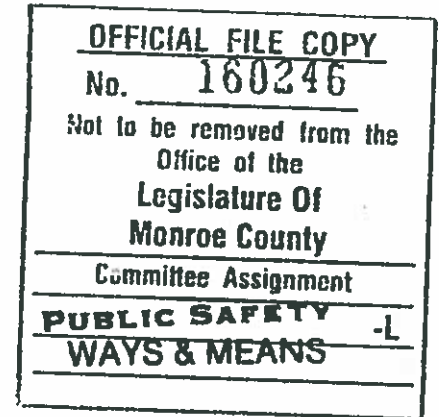

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the New York State Governor's Traffic Safety Committee, in the amount of \$95,100, for the Community Traffic Safety Program, for the period of October 1, 2016 through September 30, 2017.

The Community Traffic Safety Program grant provides funding for the Monroe County Office of Traffic Safety to promote public information and community education focusing on: teen safe driving; safe driving by the elderly; motorcycle safety; seat belt safety and child restraint education; bicycle safety; school bus safety; railway crossing safety; aggressive and distracted driving safety; and pedestrian safety. This is the fifth year the County has received this grant. This year's funding represents a decrease of \$900 from last year.

The specific legislative actions required are:

1. Authorize the County Executive, or her designee, to accept a \$95,100 grant from, and to execute a contract and any amendments thereto with, the New York State Governor's Traffic Safety Committee, for the Community Traffic Safety Program, for the period of October 1, 2016 through September 30, 2017.
2. Amend the 2016 operating grant budget of the Department of Public Safety by appropriating the sum of \$71,100 into fund 9300, funds center 2405100000, Community Traffic Safety Program.

3. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements and to make any necessary funding modifications within grant guidelines to meet contractual commitments.
4. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. 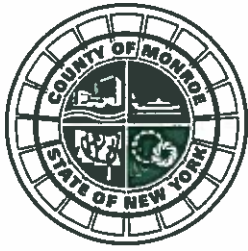

Subject: Amend Resolution 107 of 2015 to Amend and Increase the Contract with Jay A. Supnick, Ph.D. d/b/a Law Enforcement Psychological Associates for the Pre-Employment Psychiatric and Psychological Testing of Deputy Sheriff Candidates and Post-Hire Evaluations of Employees

Honorable Legislators:

This matter is being referred to Your Honorable Body at the request of Sheriff Patrick M. O'Flynn.

I recommend that Your Honorable Body amend Resolution 107 of 2015 to amend and increase the contract with Jay A. Supnick, Ph.D., d/b/a Law Enforcement Psychological Associates, from an amount not to exceed \$80,000 to an amount not to exceed \$110,000, for the pre-employment psychiatric and psychological testing of deputy sheriff candidates and post-hire evaluations of employees, for the period of May 1, 2015 through April 30, 2016, with the option to renew for two (2) additional one-year terms, in the amount of \$110,000 per year.

As part of the hiring process, Dr. Supnick will conduct psychological and psychiatric testing for candidates each year for possible employment as sheriff deputies. He will interview each candidate and report his findings to the Sheriff. In addition to pre-employment testing, Dr. Supnick will occasionally be asked by the Sheriff to evaluate existing employees to determine their mental fitness for duty and to consult with the special weapons and tactics team (SWAT) when it is deployed for certain high stress assignments, such as hostage recovery and negotiations.

The reason for the increase in the amount of the contract is the Sheriff's psychologist had to perform more pre-employment psychiatric and psychological testing and fitness for duty psychological exams for recruits than previously anticipated due to the number of academies held. Dr. Supnick performed approximately three hundred sixty (360) exams per year, rather than the two hundred seventy five (275) previously anticipated. The Sheriff's Office anticipates a similar increase in evaluations for 2016-2017 for the same reason. Additionally, the Sheriff's Office processed several lateral candidates for potential hiring and each of those candidates also required a complete evaluation. Due to the larger number of evaluations, the amount of money paid for these services was significantly more than in previous years.

A request for qualifications for pre-employment psychiatric and psychological testing services was issued and Jay A. Supnick, Ph.D. d/b/a Law Enforcement Psychological Associates was selected as the most qualified.

The specific legislative action required is to amend Resolution 107 of 2015 to amend and increase the contract with Jay A. 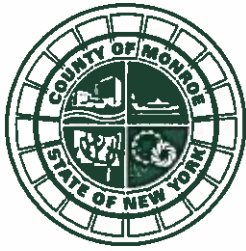

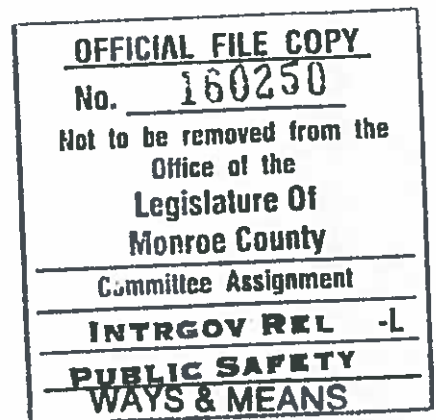

For many years Monroe County has received federal and state aid to fund the operation of the Control Center. The Control Center was recently awarded funding to continue to provide for congestion management at local signalized intersections by a central computer that maintains and improves acceptable levels of service to reduce congestion. The Control Center provides efficient traffic operations and congestion management at local signalized intersections through the Intelligent Transportation System, which is a combination of a centralized traffic signal system and a network of closed circuit traffic monitoring cameras. This system allows the Control Center to provide reliable and consistent traffic signal operation, continuously monitor traffic conditions, and make real time adjustments to the traffic signal operation to accommodate changes in traffic flow and in response to traffic incidents.

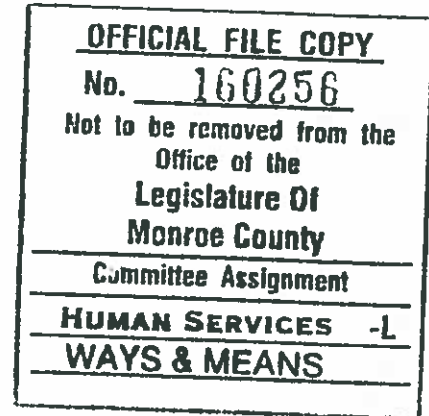

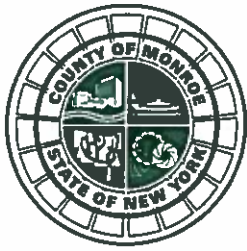

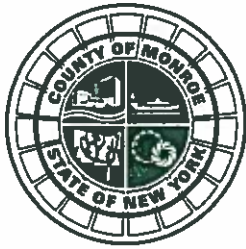

Subject: Authorize a Contract with the University of Rochester for Continuing Development and Sustainment of the County's Medical Countermeasure Program

Honorable Legislators:

I recommend that Your Honorable Body authorize a contract with the University of Rochester, in an amount not to exceed \$72,723, for continuing development and sustainment of the County's Medical Countermeasure Program, for the period of November 24, 2016 through June 30, 2017.

This contract will support the County's Medical Countermeasure Program. The University of Rochester will provide: support of exercise and drill development and implementation; communication and information management activities; Monroe County Department of Public Health staff and partner training; and completion of other related projects and activities as determined by the Program Manager of the Office of Public Health Preparedness.

A Request for Qualifications was issued for this contract with the University of Rochester the sole responder.

The specific legislative action required is to authorize the County Executive, or her designee, to execute a contract, and any amendments thereto, with the University of Rochester, 601 Elmwood Avenue, Rochester, New York 14642, for the continuing development and sustainment of the County's Medical Countermeasure Program, in an amount not to exceed \$72,723, for the period of November 24, 2016 through June 30, 2017.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

Funding for this contract is included in the 2016 operating grant budget of the Department of Public Health, fund 9300, funds center 5801090000, Office of Public Health Preparedness. No additional net County support is required in the current Monroe County budget.
