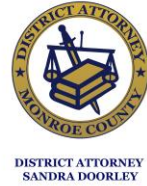

Welcome to the weekly newsletter from Monroe County District Attorney Sandra Doorley.

### *A Violent Spring*

*In 2021, we witnessed a number I never expected to see during my time in the District Attorney's Office. In the City of Rochester, there were 85 homicides. At the time this number appeared unbelievable. With my partners in law enforcement, we focused our energy and resources on illegal guns in our community, as over 70% of those homicides were committed with illegally possessed firearms.*

*We began to see a difference. By last year, homicides were down over 30% since 2021. Earlier this year, we were on schedule to have an even lower number of homicides. That was until the spring hit.*

*We are now up to 20 homicides so far this year, up 6 homicides from this time last year. I am heartbroken for these 20 families, who have buried loved ones due to senseless violence. These growing numbers from the past weeks are completely unacceptable.*

*Over the past few weeks, the city has seen an uptick in violence. I sincerely hope that this uptick is temporary and not a preview to what is to come. Our community is filled with hard working rule abiding citizens; people should not have to live in fear because of the few whose chose to terrorize our city.*

*To the victims of crime in our community and to the families who have lost loved-ones to violence, we are with you. I care about you and your loved ones, and I know my partners in law enforcement feel the same. We will continue our focus on prosecuting these atrocious cases to find justice for your family members.*

*To every concerned citizen of this county, I see you. I will ensure that the District Attorney's Office will do everything in our power to create a safer county.*

*We will search for innovative and successful ways to hold offenders accountable and work with the police officers who are conducting these investigations and making arrests in these troubling cases.*

## Sentence of Dadrick Fulwiley

34-year-old Dadrick Fulwiley was sentenced by Monroe County Court Judge Julie Hahn to 30 years to Life in the New York State Department of Corrections. Dadrick Fulwiley previously pled guilty to two counts of Murder in the 2<sup>nd</sup> Degree and Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree for the murders of Richard Collinge and MyJel Rand.

On the night of July 19, 2022 at approximately 9:00 PM, Rochester Police Officers were called to the intersection of North Clinton Avenue and Rauber Street for multiple gunshots in the area, including those that hit a house and vehicle.

On July 20, 2022, at approximately 12:30AM, Richard Collinge, MyJel Rand, and Tireek Burden were gunned down at that same corner. Following the gunshots, Rochester Police Officers arrived on scene, where Richard Collinge was pronounced dead. MyJel Rand and Tireek Burden were immediately transported to Strong Memorial Hospital, where MyJel died from his wounds.

As the investigation continued, the evidence showed that 34-year-old Dadrick Fulwiley, Kelvin Vickers and Raheim Robinson were responsible for the murders of Richard Collinge, MyJel Rand, the attempted murder of Tireek Burden, as well as the arson of the vehicle that was used in the crimes. All three were charged with multiple crimes encompassing their conduct for that five hour period. Raheim Robinson was convicted by a jury of multiple counts of Murder in the 1<sup>st</sup> Degree and multiple other violent felonies. Raheim Robinson will be sentenced on May 31, 2024, in front of Monroe County Court Judge Julie Hahn.

23-year-old Kelvin Vickers was also arrested for the murders of Richard Collinge and MyJel Rand. During the course of the investigation, Kelvin Vickers murdered Rochester Police Officer Anthony Mazurkiewicz and shot Rochester Police Officer Sino Seng. He was convicted for all three murders, and over a dozen other felony charges, and was sentenced to consecutive terms of Life without the Possibility of Parole. Dadrick Fulwiley was prosecuted by First Assistant District Attorney Perry Duckles.

## Highlights from the MCDA's Office

37-year-old **Jacklynn Barkey-Ryan** was convicted by a jury of Driving While Ability Impaired by the Combined Influence of Drugs or of Alcohol and any Drug or Drugs, and Aggravated Unlicensed Operation of a Motor Vehicle in the 1<sup>st</sup> Degree. On October 16, 2020, the defendant stopped her vehicle in the middle of the roadway on University Avenue, blocking traffic, while impaired by multiple drugs. This case was investigated by the Rochester Police Department and prosecuted by Assistant District Attorney Mikael Pelkey, of the Vehicular Crimes Bureau. Jacklynn Barkey-Ryan will be sentenced on July 16, 2024, in front of Monroe County Court Judge Randall.

28-year-old **Jaquan Owens** was convicted by a Monroe County jury of Robbery in the 1<sup>st</sup> Degree for the armed robbery of an employee at Rite Aid on August 7, 2023. This case was investigated by the Irondequoit Police Department and prosecuted by Assistant District Attorney Emily Chisholm, of the Major Felony Bureau. Jaquan Owens will be sentenced on July 1, 2024, by New York State Supreme Court Justice Moran.

19-year-old **Keyvin Miller** and 27-year-old **Kirsean Chatfield** pled guilty to Manslaughter in the 1<sup>st</sup> Degree for the fatal drive-by shooting of Eric Martin, Jr. Kirsean Chatfield also pled guilty to one count of Criminal Possession of a Weapon in the 3<sup>rd</sup> Degree. On May 31, 2023, Rochester Police Officers responded to multiple 911 calls for a shooting near Dewey Avenue in the City of Rochester. Upon their arrival to the scene, Rochester Police Officers located 21-year-old Eric Martin, Jr. sitting in the front seat of his vehicle with a gunshot wound to his head. He was immediately transported to Strong Memorial Hospital, where he died from his injury. After a thorough investigation by the Rochester Police Department, it was determined that Keyvin Miller shot Eric Martin, Jr. from a vehicle and Kirsean Chatfield was identified as the driver of the vehicle, which was stolen. Eric Martin, Jr. was not the intended target of the shooting. Immediately following the homicide, the two ditched the stolen vehicle, immediately stole a second vehicle, and then fired shots into a storefront on Parsells Avenue in the City of Rochester. On June 25, 2023, during an unrelated traffic stop, Kirsean Chatfield was located in the vehicle in possession of the weapon used to kill Eric Martin, Jr. Following an unsealed indictment, Keyvin Miller and Kirsean Chatfield were charged with the homicide. The case was prosecuted by Assistant District Attorney Camille Ingino, of the Major Felony Bureau. Keyvin Miller will be sentenced to 25 years in the New York State Department of Corrections on June 26, 2024, and Kirsean Chatfield will be sentenced to 15 years in the New York State Department of Corrections on June 13, 2024, both in front of Monroe County Court Judge Dollinger.

18-year-old **Raymar Alexander** pled guilty to Manslaughter in the 1<sup>st</sup> Degree for the fatal shooting of Chance Mosley. On November 1, 2022, Rochester Police Officers were called to a house on Weld Street in the City of Rochester. Upon arrival, the Officers found 17-year-old Chance Mosley, with one gunshot wound to his upper body, dead at the scene. After a thorough and swift investigation, 16-year-old Raymar Alexander was arrested for shooting Chance Mosley during the early morning hours of November 1, 2022. Raymar Alexander also shot himself during the altercation. Raymar Alexander will be sentenced to 17 years in the New York State Department of Corrections plus 5 years of post-release supervision. The case was prosecuted by Special Assistant District Attorney Matthew Schiano, of the Major Felony Bureau. Raymar Alexander will be sentenced on July 19, 2024, in front of acting Family Court Judge Healy.

40-year-old **Wilfredo Cruz-Rivera** pled guilty to Attempted Murder in the 2<sup>nd</sup> Degree, two counts of Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree, and Criminal Possession of a Controlled Substance in the 3<sup>rd</sup> Degree. On October 22, 2023, Wilfredo Cruz-Rivera fired multiple shots at security guards outside a bar in the City of Rochester. Fortunately, the security guard who was struck by gunfire during this incident subsequently recovered from his injuries at Rochester General Hospital. Following the shooting, Rochester Police Officers executed a search warrant, seizing multiple weapons and narcotics. Also arrested in relation to the seizure included Jordan Boards, Julio Cruz, and Damar Hughes. Both **Jordan Boards** and **Julio Cruz** pled guilty to Attempted Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree and Criminal Possession of a Controlled Substance in the 3<sup>rd</sup> Degree. All three defendants will be sentenced in front of Monroe County Court Judge Randall. **Damar Hughes** is scheduled for a jury trial on June 3, 2024, in front of Monroe County Court Judge Randall. This case was prosecuted by Assistant District Attorney Anthony Freeman, of the Non-Fatal Shooting Taskforce and Assistant District Attorney Timothy Boucher, of the Special Investigations Bureau.

New York State Supreme Court Justice Victoria Argento sentenced 50-year-old **Shon Todd** to 50 years to Life in the New York State Department of Corrections. Shon Todd was convicted by a jury of Murder in the Second Degree and Arson in the 2<sup>nd</sup> Degree for the murder of Lysandra Bagley. On May 21, 2023, Rochester Firefighters were called to a home on Garson Avenue for a house fire. After controlling the fire, a body charred beyond recognition was located inside the house. It was determined that the body was 37-year-old Lysandra Bagley, who died of multiple stab wounds before the fire. Months later, after a thorough investigation conducted by the Rochester Police Department with the assistance of the Rochester Fire Department's Arson Task Force, Shon Todd, who was the father of Lysandra Bagley's children, was arrested for the murder and the arson. During an argument, Shon Todd stabbed Lysandra then intentionally started the house fire, even though two of their children were still in the house. The case was prosecuted by Assistant District Attorney Sara VanStrydonck, Chief of the Special Victims Unit, and Assistant District Attorney Janna Jehlen, also of the Special Victims Unit.

Monroe County Judge Julie Hahn sentenced 17-year-old **Al Oliver II** to 21 years to Life in the New York State Department of Corrections for the murder of Divine Calloway. He was also sentenced concurrently to 20 years in the New York State Department of Corrections plus 2 and ½ years of post-release supervision for shooting an individual in the City of Rochester on July 13, 2023. Al Oliver previously pled guilty to Murder in the Second Degree and Assault in the 1<sup>st</sup> Degree. On July 13, 2023, Rochester Police Officers arrived to Greenley Street in the City of Rochester for reports of gunshots. There was one victim who was shot, and later recovered from his injuries. On August 10, 2023, Rochester Police Officers were called for gunshots at the corner of Central Park and Second Street. Rochester Police Officers located 18-year-old Divine Calloway, who had been shot multiple times. Divine Calloway was immediately transported to Strong Memorial Hospital, where he died shortly after his arrival. After a thorough investigation conducted by the Rochester Police Department, Al Oliver II was identified as the person who shot the victim on July 13, 2023, and also killed Divine Calloway the following month. Following the murder, the defendant fled to Florida. With assistance from the Florida Sheriff's Department, Al Oliver II was arrested and extradited to Monroe County. The case was prosecuted by Special Assistant District Attorney Adam VanHeyst, of the Non-Fatal Shooting Taskforce, and Assistant District Attorney Michael Harrigan, Chief of the Major Felony Bureau.

27-year-old **Teodoro Rivera, Jr.** was sentenced by Monroe County Court Judge Randall to 18 Years to Life in the New York State Department of Corrections for the murder of Sayyos Rios, concurrent to 15 years in the New York State Department of Corrections plus 5 years of post-release supervision for Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree. Teodoro Rivera, Jr. previously pled guilty to Murder in the 2<sup>nd</sup> Degree and Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree. On July 11, 2023, Sayyos Rios was sitting on the porch of his house on North Union Street in the City of Rochester. Teodoro Rivera, Jr. was driving in a stolen car when he aimed to shoot a separate individual standing near Sayyos Rios' house. Instead of shooting the intended target, Teodoro Rivera, Jr. shot and killed Sayyos Rios. After a thorough investigation by the Rochester Police Department, Teodoro Rivera, Jr. was arrested for the homicide and possession of an illegal firearm on September 16, 2023, on Phelps Avenue in the City of Rochester. This case was prosecuted by Special Assistant District Attorney Anthony Freeman, of the Non-Fatal Shooting Task Force.

**Rasheen Ross** was sentenced by Monroe County Court Judge Bailey-Turner to 16 year to Life in the New York State Department of Corrections. The defendant was previously convicted by a jury of Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree and Criminal Possession of a Weapon in the 3<sup>rd</sup> Degree for the illegal possession of a gun on February 23, 2018. This is Rasheen Ross' second conviction after the first came back on appeal. This case was investigated by the Rochester Police Department and prosecuted by Assistant District Attorney Matthew Schiano, of the Major Felony Bureau.

24-year-old **Nicholas Caretta** was sentenced by New York State Supreme Court Justice Moran to indeterminate term of 4-12 years in the New York State Department of Corrections. He previously pled guilty to Manslaughter in the 2<sup>nd</sup> Degree and Operator Leaving the Scene of an Incident Resulting in Death for causing the death Josiah Porchea. During the early hours of April 25, 2023, Rochester Police Officers responded to calls for a man lying in the middle of the street at E. Main Street and Richmond Street. Upon arriving at the scene, Josiah Porchea was found and immediately transported to Strong Memorial Hospital, where he was pronounced dead shortly after. After a thorough investigation by the Rochester Police Department, it was determined that Josiah Porchea was standing near his parked car when Nicholas Caretta hit him with his motor vehicle before fleeing. The case was prosecuted by Senior Assistant District Attorney Ryan Mulcahy, of the Special Investigations Bureau.

33-year-old **Joseph Scott** was sentenced by New York State Supreme Court Judge Miller to 10 years in the New York State Department of Corrections plus 5 years of post-release supervision. He was previously convicted by a jury of two counts of Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree for the illegal possession of a firearm on July 23, 2022. This case was investigated by the Rochester Police Department and prosecuted by Assistant District Attorney Michael Robertson, Deputy Chief of the Major Felony Bureau.

**David Lee Porter** was indicted on Murder in the 1<sup>st</sup> Degree, two counts of Murder in the 2<sup>nd</sup> Degree, two counts of Attempted Robbery in the 1<sup>st</sup> Degree, two counts of Robbery in the 1<sup>st</sup> Degree, Robbery in the 2<sup>nd</sup> Degree, and two counts of Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree in relation to the homicide of David Treese, III on April 22, 2024. This case is being prosecuted by 1<sup>st</sup> Assistant District Attorney Perry Duckles.

**Mark Burdick** was indicted on Murder in the 2<sup>nd</sup> Degree in relation to the homicide of Myron Fair on April 21, 2024. This case is being prosecuted by Assistant District Attorney Emily Chisholm, of the Major Felony Bureau.

**Kim Marie Carpenter-Fayko** was indicted on two counts of Grand Larceny in the 3<sup>rd</sup> Degree, three counts of Identity Theft in the 1<sup>st</sup> Degree, Criminal Possession of a Forged Instrument in the 2<sup>nd</sup> Degree, and Grand Larceny in the 4<sup>th</sup> Degree. This case is being prosecuted by Assistant District Attorney Karina Pinch, of the Public Integrity/Economic Crimes Bureau.

**Nicholas Wollaston** was indicted on two counts of Criminal Possession of a Controlled Substance in the 3<sup>rd</sup> Degree and Criminally Using Drug Paraphernalia in the 2<sup>nd</sup> Degree in relation to the possession of an illegal narcotics on December 6, 2023. This case is being prosecuted by Assistant District Attorney Jennifer Kennedy, Deputy Chief of Special Investigations Bureau.

**Alea Parker** and **Jeffrey Teike** were indicted on Criminal Possession of Stolen Property in the 3<sup>rd</sup> Degree in relation to a theft on July 30, 2023. This case is being prosecuted by Assistant District Attorney Courtney Kleiman, of the General Felony Bureau.

**Mario Lavienna, Jr.** was indicted on Burglary in the 3<sup>rd</sup> Degree in relation to a burglary of a Wegmans on January 20, 2024. This case is being prosecuted by Assistant District Attorney Terance Calcagno, of the General Felony Bureau.

**Frederick Lange** was indicted on Burglary in the 3<sup>rd</sup> Degree in relation to a burglary of a Wegmans on January 3, 2024. This case is being prosecuted by Assistant District Attorney Terance Calcagno, of the General Felony Bureau.

**Jonathan Vega-Velez** was indicted two counts of Driving While Intoxicated in relation to a vehicular incident on May 4, 2023. This case is being prosecuted by Assistant District Attorney Drew Kroft, of the Vehicular Crimes Bureau.

**Roosevelt Speed** was indicted on Criminal Possession of Stolen Property in the 4<sup>th</sup> Degree in relation to the possession of a stolen vehicle on November 12, 2023. This case is being prosecuted by Assistant District Attorney Courtney Kleiman, of the General Felony Bureau.

**Terrick Ficklin** was indicted on Robbery in the 1<sup>st</sup> Degree and Robbery in the 2<sup>nd</sup> Degree in relation to an armed robbery on October 19, 2023. This case is being prosecuted by Assistant District Attorney Emily Chisholm, of the Major Felony Bureau.

**Malachi Faulkner** was indicted on Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree in relation to possession of an illegal firearm on April 18, 2024. This case is being prosecuted by Assistant District Attorney Michael Caranante, of the Special Investigations Bureau.

**Donald Carr** was indicted on Assault in the 2<sup>nd</sup> Degree in relation to an armed assault on April 18, 2024. This case is being prosecuted by Assistant District Attorney Matthew Schiano, of the Major Felony Bureau.

**Quintora Harris** was indicted on Arson in the 3<sup>rd</sup> Degree in relation to a building fire on April 11, 2024. This case is being prosecuted by Assistant District Attorney Aliyah Fowler, of the Major Felony Bureau.

**Nicholas Stumpf** was indicted on Falsifying Business Records in the 1<sup>st</sup> Degree and Criminal Possession of Stolen Property in the 4<sup>th</sup> Degree in relation to a theft from a small business on November 21, 2023. This case is being prosecuted by Assistant District Attorney Dianna Ferretti, of the General Felony Bureau.

**Ryan Spivey** was indicted on Criminal Contempt in the 1<sup>st</sup> Degree, Criminal Mischief in the 2<sup>nd</sup> Degree, and Reckless Endangerment in the 2<sup>nd</sup> Degree in relation to a domestic incident on April 22, 2024. This case is being prosecuted by Assistant District Attorney Aaron Rath, of the Special Victims Unit.

**Jaheem Diggs** was indicted on two counts of Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree and Criminal Possession of a Weapon in the 3<sup>rd</sup> Degree in relation to the illegal possession of a firearm on April 19, 2024. This case is being prosecuted by Assistant District Attorney Ryan Mulcahy, of the Special Investigations Bureau.

**Kim Manning** was indicted on two counts of Driving While Intoxicated, Aggravated Driving Intoxicated With a Child Passenger, and Endangering the Welfare of a Child in relation to a vehicular incident on January 9, 2024. This case is being prosecuted by Assistant District Attorney Kelly Pettrone, of the Vehicular Crimes Bureau.

**Marvin Porter** was indicted on Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree in relation to the possession of an illegal firearm on April 18, 2024. This case is being prosecuted by Assistant District Attorney Bridget Morgan, of the Special Investigations Bureau.

**Miguel Cruz-Rivera** was indicted on Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree and two counts of Criminal Possession of a Controlled Substance in the 3<sup>rd</sup> Degree in relation to the illegal possession of a firearm, fentanyl, and cocaine on April 21, 2024. This case is being prosecuted by Assistant District Attorney Michael Caranante, of the Special Investigations Bureau.

**Franny Villegas** was indicted on two counts of Driving While Intoxicated, Aggravated Driving Intoxicated With a Child Passenger, and Aggravated Unlicensed Operation of a Motor Vehicle in the 3<sup>rd</sup> Degree in relation to a vehicular incident on November 25, 2023. This case is being prosecuted by Assistant District Attorney Jonathan Jirik, of the Vehicular Crimes Bureau.

**Darnell Gomenginger** was indicted on Burglary in the 3<sup>rd</sup> Degree in relation to a burglary of a Walgreens on April 24, 2024. This case is being prosecuted by Assistant District Attorney Angela Carson, of the General Felony Bureau.

**Dale Mahoney, Jr.** was indicted on Criminal Contempt in the 1<sup>st</sup> Degree, Criminal Mischief in the 2<sup>nd</sup> Degree, two counts of Aggravated Family Offense, and Petit Larceny in relation to a domestic incident on April 6, 2024. This case is being prosecuted by Assistant District Attorney Aaron Rath, of the Special Victims Unit.

**Deangelo Pearson** was indicted on Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree in relation to the illegal possession of a firearm on April 27, 2024. This case is being prosecuted by Assistant District Attorney Kaylee Rizzari, of the Special Victims Unit.



**Quincy Clayton, Jr.** was indicted on two counts of Criminal Mischief in the 3<sup>rd</sup> Degree in relation to damaging property of the Rochester Police Department on February 10, 2024 and April 27, 2024. This case is being prosecuted by Assistant District Attorney Angela Carson, of the General Felony Bureau.

**Alvis Dukes** was indicted on two counts of Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree, Criminal Possession of a Controlled Substance in the 3<sup>rd</sup> Degree, Criminal Possession of a Weapon in the 5<sup>th</sup> Degree, and Criminally Using Drug Paraphernalia in the 2<sup>nd</sup> Degree. This case is being prosecuted by Assistant District Attorney Michael Caranante, of the Special Investigations Bureau.

**Randy Hall** was indicted on Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree in relation to the possession of an illegal firearm on April 27, 2024. This case is being prosecuted by Assistant District Attorney Tony DiPerna, of the Special Investigations Bureau.

**Bradley Allen** and **Charles Noble** were indicted on two counts Criminal Possession of a Controlled Substance in the 3<sup>rd</sup> Degree and two counts of Criminally Using Drug Paraphernalia in the 2<sup>nd</sup> Degree in relation to the illegal possession of illegal narcotics on November 29, 2023. This case is being prosecuted by Assistant District Attorney Ryan Mulcahy, of the Special Investigations Bureau.

**Antonio McIntyre, Raquel Melecio, and Justin Melton** were indicted on three counts of Criminal Possession of a Controlled Substance in the 3<sup>rd</sup> Degree and Criminal Possession of a Controlled Substance in the 4<sup>th</sup> Degree. Antonio McIntyre was also indicted on Criminal Possession of a Controlled Substance in the 1<sup>st</sup> Degree, an additional four counts of Criminal Possession of a Controlled Substance in the 3<sup>rd</sup> Degree, an additional count of Criminal Possession of a Controlled Substance in the 4<sup>th</sup> Degree, five counts of Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree, and two counts of Criminal Possession of a Weapon in the 3<sup>rd</sup> Degree. This case is being prosecuted by Assistant District Attorney Jennifer Kennedy, Deputy Chief of the Special Investigations Bureau.

**Herbert Smith** was indicted on Burglary in the 3<sup>rd</sup> Degree in relation to a burglary of a Walmart on February 18, 2024. This case is being prosecuted by Assistant District Attorney Angela Carson, of the General Felony Bureau.
