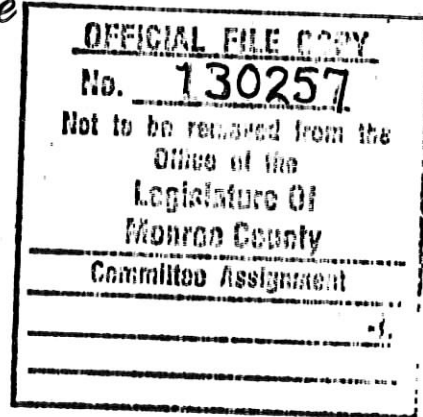

Re: Memorializing the New York State Assembly to Pass Assembly Bill A.7254 and to Enact the Appropriate Amendments to the "Trafficking Victim's Protection and Justice Act"; Making Various Provisions Relating to Prostitution Offenses; and Creating Crimes of Aggravated Patronizing of a Minor for Prostitution


Honorable Legislators:

Human trafficking is an atrocious crime which requires punishment to the fullest extent of the law. The United States Department of Justice estimates that over 18,000 people are trafficked into the country every year and that over 300,000 children are vulnerable and at risk of becoming sexually exploited. Among these national statistics from the Department of Justice, New York State ranks 4th in the nation for human trafficking. According to the National Human Trafficking Resource Center, a total of 868 calls involving human trafficking have been reported for the year 2012 in New York State. The City of Rochester currently ranks 4th in the state for calls submitted regarding human trafficking.

In a report card issued by Shared Hope International in conjunction with the American Center for Law and Justice, each states' legislative handling of human trafficking issues were ranked on 41 key legislative components that must be addressed in a state's laws in order to effectively respond to the crime of domestic minor sex trafficking. New York State received a score of a 62 out of an overall score of 100 resulting in a D rating. In an attempt to establish harsher penalties against human traffickers, Assembly Bill A. 7254 was submitted to improve the State's response to human trafficking. This Bill already passed by the New York State Senate, enhances penalties and protects victims, particularly in instance of commercial sexual exploitation of children, and increasing the accountability of buyers and traffickers who are fueling the growth of this underground industry.

Therefore, I urge you to join me in memorializing the New York State Assembly to pass Assembly Bill A.7254 and enact the Trafficking Victim's Protection and Justice Act, which will provide harsher penalties for those who promote the industry of human trafficking. New York State needs to strengthen their current laws that address this industry. By passing these measures, New York will take the needed step in bringing an end to the horrible crime of human trafficking.

Honorable Legislators:


Recently, Unshackle Upstate unveiled their "New Era for Upstate" plan. The goal of the plan is to encourage job growth by reducing state income taxes by 25% for upstate residents who make less than \$50,000; reducing, and eventually repealing, the corporate franchise tax for upstate businesses; reducing the state sales tax by 50% in certain upstate counties; and eliminating the 18A energy assessment for upstate manufacturers.


New York's tax burden is consistently ranked among the worst in the nation. In Upstate, this has discouraged new job growth and driven families and existing businesses from our region. In recent years, state leaders have actively pursued policies that cut taxes and target investments in Upstate, but much more needs to be done.







RE: Enact a Local Law to Authorize a Tax Exemption for Improvements to Real Property in Monroe County Meeting Certification Standards for Green Buildings

Honorable Legislators:

We recommend that Your Honorable Body enact a local law to grant property tax exemptions for improvements to real property meeting certification standards for green buildings.

New York State Real Property Tax Law (RPTL) offers local governments the option to grant tax reductions and/or exemptions. By opting into a section of this law, a municipality can provide tax benefits to people who meet certain requirements.

Section 470 of the RPTL permits us to enact a local law to exempt from taxation improvements made to real property when those improvements meet standards for green buildings, LEED certification standards for green buildings as provided in this section, the National Green Building Standard, the green building initiative's green globes rating system, the American National Standards Institute, or substantially equivalent standards for certification using a similar program for green buildings as determined by the municipal corporation.

By enacting this local law, we will provide local residents with an incentive to improve their properties in a sustainable way, thereby helping the environment, improving the housing stock and creating much needed construction jobs.


The specific legislative actions required are:

1. Schedule and hold a public hearing on the attached local law.

2. Enact the attached local law to grant property tax exemptions for improvements to real property meeting certification standards for green buildings.

This proposal will have no impact on the revenue and/or expenditures of the current Monroe County Budget as it will take effect January 1, 2014.





LOCAL LAW NO. _____ OF 2013

A LOCAL LAW ENTITLED "AUTHORIZE A TAX EXEMPTION FOR IMPROVEMENT TO REAL PROPERTY IN MONROE COUNTY MEETING CERTIFICATION STANDARDS FOR GREEN BUILDINGS"

BE IT ENACTED BY THE LEGISLATURE OF THE COUNTY OF MONROE, as follows:

Section 1. Pursuant to Chapter 188 of the Laws of 2012 and Section 470 of the Real Property Tax Law, and as provided under said section, this Body hereby authorizes an exemption from taxation to the extent of any increase in assessed value of residential property resulting from improvements to real property meeting certification standards for green buildings.

Section 2. Such real property, or portion thereof, which is certified under a LEED certification standard for the categories of certified silver, gold or platinum as meeting green building standards, as determined by a LEED accredited professional, National Green Building Standards accredited professional, or other green standards as identified in Part 1 of Section 470 of the Real Property Tax Law, shall be exempt as provided below for the respective percentages as established in this local law and provided further, that a copy of the LEED certification, National Green Building Standard certification, or other certifications as listed in Part 1 of Section 470 of the Real Property Tax Law, for a qualified category is filed with the assessor's office and is approved by the assessor as meeting the requirements of this local law. Such exemption shall be to the extent of any increase in assessed value resulting from the construction or reconstruction of a property meeting a green certification as identified in Part 1 of Section 470 of the Real Property Tax Law.

Section 3. In order to qualify for this exemption, local labor must be used. Local labor is defined as residing in Monroe, Genesee, Livingston, Orleans, Ontario, Seneca, Wayne,

Wyoming, or Yates Counties. In some instances, use of 100% local labor may not be possible for any of the following reasons:

1. Warranty issues related to installation of specialized equipment whereby the manufacturer requires installation by only approved installers.
2. Specialized construction in which a local contractor is not available.
3. Significant cost differentials in bids whereby use of local labor significantly increases the cost of the project. A cost differential of 25% is deemed significant.
4. No local labor is available for the project.

Section 4. This local law shall take effect for assessment rolls prepared on the basis of taxable status date occurring on or after December 31, 2013, and upon filing in the office of Secretary of State as provided in Section 27 of the Municipal Home Rule Law.

Section 5. If any clause, sentence, paragraph, section, subdivision or other part of this Local Law or its applications shall be adjudged by a Court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or otherwise invalidate the remainder of this Local Law which shall remain in full force and effect except as limited by such order or judgment.

Swatch Group (U.S.) Inc. requested that the MCSO provide security services for the Omega Watch Tent for this event in an effort to safeguard its product at the 2013 PGA Championship.

The specific legislative action required is to authorize the County Executive, or her designee, to execute a contract, and any amendments thereto, with Swatch Group (U.S.) Inc., 1200 Harbor Boulevard, 7th Floor, Weehawken, New Jersey 07086, in an amount not to exceed \$7,000, for the provision, by the Monroe County Sheriff's Office, of security services for the Omega Watch Tent at the 2013 PGA Championship, from 7:00 p.m. to 7:00 a.m. daily, starting August 4, 2013 at 7:00 p.m. and ending Sunday, August 11, 2013 at 7:00 a.m.

Funding for these services is included in the 2013 operating budget of the Office of the Sheriff, fund 9001, funds center 3803010000, Sheriff Police Bureau Administration. No additional net County support is required in the current Monroe County budget.

Honorable Legislators:

This matter is being referred to Your Honorable Body at the request of Sheriff Patrick M. O'Flynn.

I recommend that Your Honorable Body accept a grant from the New York State Office of Victim Services, in the amount of \$186,750, for the Sheriff's Victim Assistance Program, for the period of October 1, 2013 through September 30, 2014.

This grant from the New York State Office of Victim Services funds three (3) Victim Assistance Advocate positions within the Sheriff's Office. These advocates implement a comprehensive program that engages victims at the crime scene or immediately thereafter (as needed) and supports them through the criminal justice system. Services include crisis support, outreach through the home, workplace and hospital, referral services, case status updates, short term counseling for victims and their families, advocacy at court proceedings including the provision of information and accompaniment to court, assistance with property recovery and reimbursement for lost wages and medical bills through compensation claim assistance. This will be the 24th year the County has received this grant. This year's funding represents no change from the previous 12-month period.

The specific legislative actions required are:

1. Authorize the County Executive, or her designee, to accept \$186,750 grant from, and to execute a contract and any amendments thereto with, the New York State Office of Victim Services, for the Sheriff's Victim Assistance Program, for the period of October 1, 2013 through September 30, 2014.

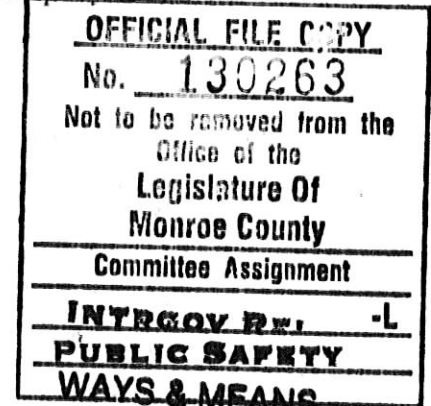

Honorable Legislators:

This matter is being referred to Your Honorable Body at the request of Sheriff Patrick M. O'Flynn.

I recommend that Your Honorable Body authorize an intermunicipal agreement with the City of Rochester to accept a gift of equipment for use by the Monroe County Sheriff's Office, consisting of SWAT night vision goggles, helmets and mounts, with an approximate cumulative value of \$79,999.


This gift of equipment is the result of a grant awarded to the Rochester Police Department (RPD) by the New York State Division of Homeland Security UASI Grant through the Rochester Regional Urban Area Working Group. The equipment will enhance the response capabilities of the Monroe County Sheriff's Office's SWAT Team and enable it to work more collectively with RPD's SWAT team.

The specific legislative action required is to authorize the County Executive, or her designee, to execute an intermunicipal agreement, and any amendments thereto, with the City of Rochester, to accept a gift of equipment for use by the Monroe County Sheriff's Office, consisting of SWAT night vision goggles, helmets and mounts, with an approximate cumulative value of \$79,999.

This gift is 100% funded by the New York State Division of Homeland Security and Emergency Services and will have no impact on the revenues or expenditures of the current Monroe County budget.

Subject: Acceptance of a Grant from the New York State Office of Emergency Management for the Federal Emergency Management Agency - Legislative Pre-Disaster Mitigation 2008 Program and Authorize an Intermunicipal Agreement with the Town of Henrietta

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the New York State Office of Emergency Management, in the amount of \$1,000,000, and authorize an intermunicipal agreement with the Town of Henrietta, in the amount of \$47,288, for the Federal Emergency Management Agency - Legislative Pre-Disaster Mitigation 2008 Program, for the period of October 18, 2012 through October 18, 2014.

This program is designed to reduce future disaster damages by providing financial support to implement cost-effective mitigation measures. These funds will reimburse the County for the purchase and installation of eight (8) fixed generators at government owned facilities and in the Town of Henrietta. The Town of Henrietta was a partner with the County in the 2009 grant application program. This is the first year the County has received this grant. The generators will be installed at the following locations:

Monroe County Public Safety Building
Monroe County Hall of Justice
Monroe County Civic Center Jail
Town of Henrietta Department of Public Works
Monroe County Public Safety Communications Tower Sites in Mendon, Fairport,
Webster and Rochester

The specific legislative actions required are:

1. Authorize the County Executive, or her designee, to accept a \$1,000,000 grant from, and to execute a contract and any amendments thereto with, the New York State Office of Emergency Management, for the Federal Emergency Management Agency - Legislative Pre-Disaster Mitigation 2008 Program, for the period of October 18, 2012 through October 18, 2014.

This grant requires a 25% match of the total project cost. The cash and in-kind services match will be provided through various County departments (or divisions) and the Town of Henrietta on a pro rata basis. No additional net County support is required in the current Monroe County budget.

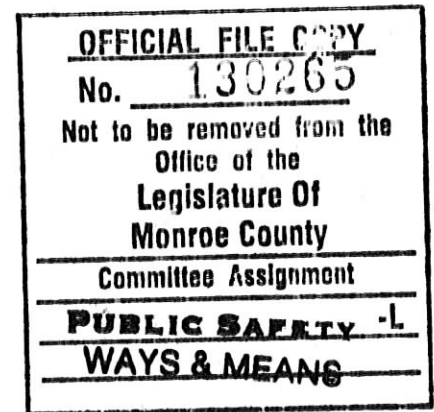

Subject: Acceptance of a Grant from the New York State Division of Criminal Justice Services for the 2013-2014 Aid to Crime Laboratories Program (Monroe County Crime Laboratory)

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the New York State Division of Criminal Justice Services, in the amount of \$636,300 for the Aid to Crime Laboratories Program, for the period of July 1, 2013 through June 30, 2014.

This grant will enable the Monroe County Crime Laboratory, which serves Monroe County and seven surrounding counties, to reimburse the payroll and fringe benefits for eight (8) existing positions within the Monroe County Crime Lab. Funding will supplement the Laboratory's operational budget for supplies, software maintenance agreements, maintenance of equipment, and expenses related to the continued accreditation of the Laboratory. This is the seventh year the County has received this grant. This year's funding represents a decrease of \$74,800 from last year.

The specific legislative actions required are:

1. Authorize the County Executive, or her designee, to accept a \$636,300 grant from, and to execute contracts and any amendments thereto with, the New York State Division of Criminal Justice Services, for the Aid to Crime Laboratories Program, for the period of July 1, 2013 through June 30, 2014.
2. Authorize the County Executive to reappropriate any unencumbered balances during the grant period according to the grantor requirements and to make any necessary funding modifications within grant guidelines to meet contractual commitments.

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the New York State Division of Criminal Justice Services, in the amount of \$90,000, for the 2013-2014 Aid to Crime Laboratories Program, related to the Office of the Medical Examiner, for the period of July 1, 2013 through June 30, 2014.

The purpose of the current grant is to support ongoing services provided by the lab, to provide the quality control oversight required to maintain American Board of Forensic Toxicology accreditation and New York State certification, and to assist the lab in improving turnaround times and reducing backlog. The Office of the Medical Examiner's Forensic Toxicology Laboratory serves law enforcement agencies, District Attorneys' offices and constituents in the County and surrounding region. Activities for this 12-month period will be coordinated with work in progress from the prior award, which was adopted by Resolution 267 of 2012.

Funds will be used for preventive and routine maintenance on a Liquid Chromatograph/Mass Spectrometer/Mass Spectrometer instrument, which enhances the analytical capabilities of the Laboratory. 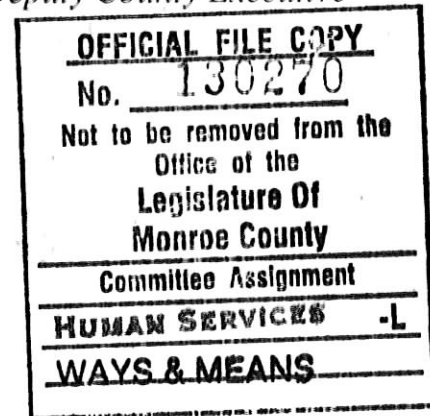
