Deputy Sheriff Road Patrol (Lateral)

Age Requirement

There is no maximum age for Laterals to the Deputy Sheriff Road Patrol.

Education

A high school diploma or GED is the minimum requirement. Applicants should be aware that Deputy Sheriff positions are highly competitive in a field of candidates with varying degrees of educational backgrounds and experience. Only the most qualified candidates are selected.

Residency

Applicants must reside within Monroe County or in one of the boarding Counties on or before the date of appointment. (*Orleans, Genesee, Livingston, Ontario, Wayne*)

Scope of work

Deputy Sheriffs in the Police bureau are members of the Road Patrol. The Road Patrol is responsible for public safety by the enforcement of all local, state, and federal laws through various assignments. Under the heading of Police Bureau, you will also find the Criminal Investigations Section, Tactical Enforcement Unit, K-9 Unit, SCUBA Unit, Crime Scene Investigations, Fire Investigations, Major Felony Unit, Warrants Squad, SWAT, Drone Response Team, and Hostage Negotiation Team.

Additional Information

Applicants must have a valid NYS Driver's license, No Felony convictions, be of "Good moral" character, and be in good physical condition.

Applicants must hold a valid New York State Police Officer Certification from an accredited Police Agency and is in good standing.

Applicant must have been established from a competitive civil service exam and will need to provide a copy of the roster card and civil service job announcement they were hired from.

The Selection Process

The selection process takes about six to eight months

- **Command Staff Interviews**

Applicants will be interviewed by several commanding officers. Candidates will discuss their interests in the Monroe County Sheriff's.

A conditional job offer will be made after. A conditional job offer means that you must pass the remaining levels of testing for further consideration.

- **Medical**

Prior to appointment to probationary status, Applicants will undergo a complete physical, which includes drug screening, to certify the general health of each candidate.

- **Psychological**

Prior to appointment to probationary status, Applicants will undergo a series of psychological exams, conducted and assessed by a qualified professional. These exams are divided into a written exam and an oral exam. The written exam may take up to 8 hours and the oral exam, usually administered on a later date, lasts from 30 minutes to an hour. Both exams will determine the candidate's fitness to be a Deputy Sheriff.

- **Polygraph/Background Investigation**

Applicants will undergo an extensive background investigation includes verification of qualifying credentials, a review of any criminal record, and verification of at least three personal references. The applicant might also be subjected to submit to a polygraph examination. This will be used to determine the applicant's moral character and qualifications to be a Deputy Sheriff.

- **Selections by the Sheriff/Job Offer**

The Sheriff will convene a meeting of several members of his staff to discuss each candidate's results. The Sheriff will then make selections from the pool of candidates and the final job offer will be made to those selected candidates. Those candidates not selected will be informed in writing within 30 days of such decision.
