**RE: Memorializing the New York State Assembly to Pass and Governor Andrew M. Cuomo to Sign Assembly Bill 2906 and Senate Bill 283 which Amends the Penal Law to Criminalize the Desecration a Veteran's Gravesite**

Honorable Legislators:

United States veterans are among the most honored of our citizens. These men and women risked their lives to protect the values and liberties that we, as Americans, hold closest to our hearts. These individuals deserve our utmost respect, even after their passing. The vandalism of veteran cemetery plots in the United States has recently reached an all-time high. Without a clear definition of a crime, many of these vandals are defacing the graves of our deceased veterans. This not only causes pain to family members of these veterans but reduces the honor given to these individuals.

The desecration of graves and cemetery plots of veterans is not just a national problem, but is also affects Monroe County and the surrounding area. At St. Mary's Cemetery in Waterloo, two dozen bronze plaques were stolen from the graves of deceased veterans. The plaques were destroyed to the point that they were unidentifiable. These instances are happening all over the State of New York and could impact Monroe County in the near future.


With Veterans buried in almost every cemetery in Monroe County, the vandalism of these cemetery plots is unacceptable. Senate Bill 283 and Assembly Bill 2906, co-sponsored by State Senator Ted O'Brien and sponsored by Assemblyman Joe Morelle respectively, makes the desecration of a veteran's grave a class E felony with additional penal provisions. The bill, which has already passed in the State Senate, criminalizes the vandalism of veterans' gravesites and provides law enforcement with a tool to prosecute offenders.

As residents of Monroe County and citizens of the United States, we must do everything in our power to protect the honor of our veterans. Therefore, I urge you to join in memorializing the New York State Assembly to pass and Governor Andrew M. Cuomo to sign Assembly Bill 2906 to criminalize the desecration of a veteran's grave.

**Re: Memorializing the New York State Assembly and the New York State Senate to Oppose the Governor's Plan to Provide Funding for College Degrees for Prisoners**

Honorable Legislators:

One of the greatest burdens presently affecting citizens are the overwhelming costs associated with higher education. The majority of our young adults leave college loaded with a debt load higher than it has ever been in the past. Students and parents alike are faced with the hardship of carrying it for many years.

Governor Andrew M. Cuomo has recently proposed a plan to fund college education for prison inmates. While the cost remains unclear, the Governor plans to pilot this program at ten prisons starting this year. Ultimately, this program would expand in the following years. This program would be funded entirely with public money, forcing struggling parents and students to pay not only for their child's or their own college education, but also for the education of incarcerated people.

This proposal is an unwise use of taxpayer money in the State of New York. Not only does it allocate public funds to individuals who are already costing taxpayers approximately \$60,000 each year, but it also ignores the struggles of New York tax-payers who are strapped with an average of \$26,000 in student loans. Governor Cuomo cites New York's high rate of recidivism as a driving force behind this program; however, he recognizes that the drop in recidivism could be minimal.

Legislators on both sides of the aisle have already begun to object to this program. In consideration of the many parents and students in Monroe County who are dealing with these incredible student loan burdens, I urge you to join in memorializing the New York State Legislature to oppose the any spending which would provide free college education to prisoners.

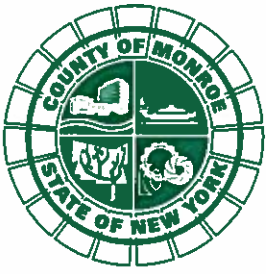

**RE: Memorializing the United States Congress and President Barack Obama to Oppose H.R. 217, the Title X Abortion Provider Prohibition Act.**

Honorable Legislators:

A woman's ability to receive primary health care and family planning services should not be a privilege. However, this could be the reality for millions of women if H.R. 217, the Title X Abortion Provider Prohibition Act is passed. This proposed bill would have devastating effects on both men and women and could lead to far greater health crises.

The purpose of this bill, according to House Republicans such as co-sponsor and local Congressman Thomas Reed (R-Corning), is to prohibit any federal family planning assistance to any entity that performs abortions. However, the removal of federal funding from such health care facilities would actually deny women the ability to receive life-saving care.

One such provider, Planned Parenthood, has written extensively on this harmful bill and the effect it would have on its patients. Planned Parenthood estimates that 3 million men and women visit their clinics annually. Of those 3 million, 97% visit for health care services such as annual exams, breast cancer screening, cervical cancer, and contraceptives. They also obtain health education and are assessed for hypertension and diabetes. These services could not continue if federal funding is prohibited.

Advocates for women's health have argued that this bill falsely gives the impression to the public that it would reduce the number of abortions performed nationally. According to the National Women's Law Center, H.R. 217 would not reduce the need for abortion or address taxpayer funding of abortions. Instead, it threatens the health of lower income women who turn to Title X clinics for preventive health care, family planning and cancer screening.

Therefore, I urge you to join me in memorializing the United States Congress and President Barack Obama to oppose H.R. 217, the Title X Abortion Provider Prohibition Act.





**RE: Memorializing the United States Congress and President Barack Obama to Oppose The Tax Reform Act of 2014.**

Honorable Legislators:

Congressional Republicans, led by Representative Dave Camp (R-MI), have unveiled The Tax Reform Act of 2014 that would disproportionately raise taxes for residents of New York State. They are proposing to eliminate the deduction for state and local taxes, which allow taxpayers who itemize deductions to subtract general state and local taxes when calculating their federal taxable income.

This elimination would be a staggering blow for New York State Residents. Eliminating this deduction would significantly increase taxes on a large number of New Yorkers and Monroe County residents. According to one federal official, eliminating this reduction would result in a nearly \$15 billion tax increase for New York families, an average increase of more than \$4,500 per tax payer. Monroe County residents simply can't afford to pay \$4,500 in new taxes.

This proposal is being presented as if it is a means to strengthen the United States economy. However, instead of helping small, family-owned businesses, it would offer incentives and tax breaks to multinational corporations. Further, it would allow oil and gas pipeline companies to charge their customers the costs of deferred corporate income tax, despite the fact that companies themselves are exempt from such taxes.

Therefore, I urge you to join me in memorializing the United States Congress and President Barack Obama to oppose the Tax Reform Act of 2014.

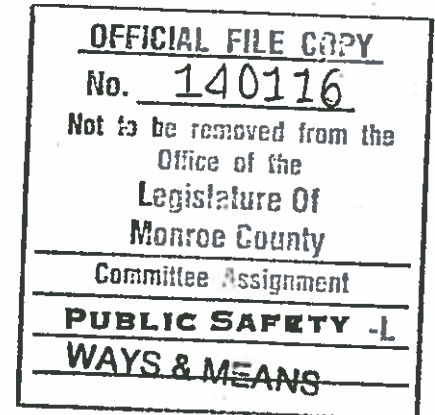

**Subject:** Acceptance of a Grant from the New York State Division of Homeland Security and Emergency Services for the Technical Rescue/Urban Search and Rescue Grant Program

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the New York State Division of Homeland Security and Emergency Services, in the amount of \$133,626, for the Technical Rescue/Urban Search and Rescue Grant Program, for the period of November 12, 2013 through December 31, 2014.

The New York State Division of Homeland Security and Emergency Services provides funding to support Monroe County's effort to continue development of technical rescue capabilities for the community. The intent of this grant is to promote regional partnerships using local agencies for all technical rescue training and field operations. This program directly supports the on-going activities of the Monroe County Special Operations Unit Work Group which is focused on organizing these types of special capabilities as a single response entity in the community.

Specifically, this grant will enhance the ability to respond to structural collapse, trench, rope, confined space, swift/ice/cold water rescues and hazardous material responses and mitigation. This is the fifth year the County has received this grant. This year's funding represents an increase of \$140 from last year.

**The specific legislative actions required are:**

1. Authorize the County Executive, or her designee, to accept a \$133,626 grant from, and to execute a contract and any amendments thereto with, the New York State Division of Homeland Security and Emergency Services, for the technical Rescue/Urban Search and Rescue Grant Program, for the period of November 12, 2013 through December 31, 2014.
2. Amend the 2014 operating grant budget of the Department of Public Safety by appropriating the sum of \$133,626 into funds 9300, fund center 2408020100, Monroe County Fire Bureau.

Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within grant guidelines to meet contractual commitments.
4. Should the funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law and, when applicable, the terms of any labor agreement affecting such positions.

Environmental assessments were completed for this grant and it was determined that there would be no significant effect on the environment.

This grant is 100% funded by the New York State Division of Homeland Security and Emergency Services. No net County support is required in the current Monroe County budget.

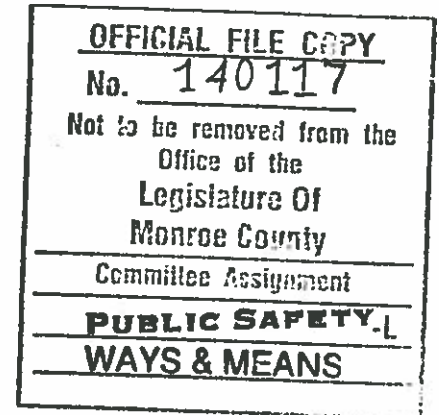

**Subject:** Acceptance of a Grant from the New York State Division of Criminal Justice Services for Supervision and Monitoring Costs of the Ignition Interlock Devices Program

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the New York State Division of Criminal Justice Services, in an amount not to exceed \$176,225, for reimbursement of supervision and monitoring costs of the Ignition Interlock Devices Program, for the period of October 1, 2013 through September 30, 2014.

This grant provides funds to defray the costs of implementing Leandra's Law and the supervision and monitoring of probation and conditional discharge cases that include an Ignition Interlock Device (IID). A component of Leandra's Law is that, as a part of the sentence in all driving while intoxicated (DWI) convictions, an IID must be installed on all vehicles owned or operated by an offender. IID's are breath-testing devices attached to the vehicle's ignition system, and the operator cannot start the car without blowing a successful Blood-Alcohol-Content test. The operator must also submit to 'rolling retests' as the car is driven. An installed camera allows confirmation of the driver's identity.

Monroe County will be reimbursed for each court order that requires IID installation and monitoring. Reimbursed costs include a portion of the salaries and benefits of Probation Officers and other staff who monitor DWI offenders. New York State anticipates that Monroe County will receive 1,600 cases per year that include IID's. This is the fourth year the County will receive this grant. This year's funding represents a decrease of \$11,588 from last year's reimbursement.

Subject: Authorize a Contract with Western New York Polygraph Services, Inc., for Polygraph Examination Services

Honorable Legislators:

I recommend that Your Honorable Body authorize a contract with Western New York Polygraph Services, Inc., in an amount not to exceed \$10,000, for polygraph examinations of convicted sex offenders, for the period of January 1, 2014 through December 31, 2014, with the option to renew for two (2) additional one-year terms, in an amount not to exceed \$10,000 annually.

Polygraph examinations are conducted on post-conviction sex offenders who have been sentenced to probation and are in treatment. The polygraphs are used for supervision and treatment purposes. Offenders will receive a sexual history (disclosure) polygraph, with subsequent polygraphs at six-month intervals or upon certain incidents. A written report will be provided for each examination. This is the first year that the County will contract with Western New York Polygraph Services, Inc. for this service.

A Request for Qualifications was issued for this service and Western New York Polygraph Services, Inc. was selected as the most qualified to provide this service.

**The specific legislative action required is to authorize the County Executive, or her designee, to execute a contract, and any amendments thereto, with Western New York Polygraph Services, Inc., 295 Main Street, Suite 1074, Buffalo, New York 14203, for polygraph examinations of convicted sex offenders, in an amount not to exceed \$10,000, for the period of January 1, 2014 through December 31, 2014, with the option to renew for two (2) additional one-year terms, in an amount not to exceed \$10,000 annually.**

**Subject:** Authorize a Contract with Costich Engineering, Land Surveying and Landscape Architecture, P.C. for General Engineering Term Services

Honorable Legislators:

I recommend that Your Honorable Body authorize a contract with Costich Engineering, Land Surveying and Landscape Architecture, P.C., in an annual amount not to exceed \$75,000, for general engineering term services, for the period of May 1, 2014 through April 30, 2015, with the option to renew for two (2) additional one-year terms, with escalations for the terms to be limited to the amount equal to the increase in the previous year's Consumer Price Index (U.S. City Average CPI-U from the Bureau of Labor Statistics).

The scope of services generally consist of providing consultation, design, survey and mapping, and construction inspection on an as-needed basis concerning upcoming signal, highway, bridge, or culvert projects scheduled for construction as part of the Department of Transportation's highway major maintenance, capital culvert replacement program, traffic engineering or spot improvements programs. The services will be used for design of projects to improve the condition of road surfaces, make drainage improvements, including highway culverts, and increase safety by improving traffic signals, highway alignment, profile, and sight distance. The Department of Transportation does not routinely conduct in-house design and would utilize these services as an extension of its staff on an as-needed basis.

Subject: Authorization to Advertise for Bids for the Bridge Preventive Maintenance Project  
in the Towns of Brighton, Greece and Wheatland

Honorable Legislators:

I recommend that Your Honorable Body authorize the Department of Transportation to advertise for bids for the Bridge Preventive Maintenance Project in the Towns of Brighton, Greece and Wheatland.

This project involves the preventive maintenance of four (4) bridges: Edgemere Drive over Buck Pond outlet in the Town of Greece; North Greece Road over Northrup Creek in the Town of Greece; Wheatland Center Road over Oatka Creek in the Town of Wheatland; and South Winton Road over the Erie Canal in the Town of Brighton. The work varies by bridge, but includes field cleaning and painting of structural steel, sealing all exposed concrete, upgrading bridge railing, bearing restoration or replacement, concrete deck repairs or replacement, installing new waterproofing membrane, repairs to abutments and wingwalls and joint seal replacements.

Plans, specifications and cost estimates have been prepared and the Department of Transportation is ready to advertise for bids. In lieu of a public information meeting, newsletters were sent out to residents informing them of the project. The total anticipated construction cost is \$2,200,000, which includes the following estimated amounts:

Construction Cost	\$1,755,000
Construction Supervision	270,000

I recommend that Your Honorable Body amend the 2014 Capital Budget and Bond Resolution 328 of 2012 to provide an increase in funding and authorize a contract with C.P. Ward, Inc., in the amount of \$549,050 for construction services, for the Preventive Maintenance Bridges/Rustic Rail Replacement Project in the Towns of Brighton, Perinton, Parma and Pittsford.

This project involves the preventive maintenance repairs and rustic rail replacement for four (4) bridges. The work to be performed are element specific repairs and will include replacement of bridge joints, replacement of bearings and pedestals where warranted, concrete deck and substructure repairs and replacement of rustic guide rail. There are currently insufficient funds available for the project due to increased costs since it was initially programmed in the Capital Improvement Program. The bid analysis revealed that the engineer's estimate was below the average bid prices for several items, but particularly for many small quantity items. Further, the work is in four (4) different locations so additional construction costs will result but were not considered when looking at the estimate. Last, the construction inspection costs were also increased to lengthen the inspection period from three (3) to four (4) months and to include additional materials testing. These increases result in an additional \$125,000 over the project budget. The total estimated project cost is now \$777,000.

Major funding will be provided from Federal and State Aid in the amount of approximately 95% of the project cost with overall project administration by Monroe County.

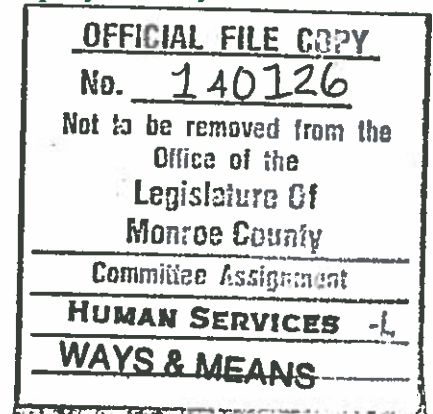

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the New York State Department of Health (NYSDOH), in the amount of \$574,071, to support the Monroe County Nurse-Family Partnership Program (NFP), for the period of September 30, 2013 through September 29, 2016, and amend Resolution 292 of 2013, to increase the contract with Visiting Nurse Service of Rochester and Monroe County, Inc., to a total amount not to exceed \$882,631 for the Nurse-Family Partnership Program, for the period of January 1, 2014 through December 31, 2014.

The purpose of this grant is to provide support of the County's existing NFP program. The NFP program is an evidence-based nurse home visiting program that has been rigorously evaluated and includes expertly trained nurses delivering the services per a standard curriculum. The grant will provide a portion of the funding for the NFP program, annually providing home visits to approximately 300 high-risk, first time mothers, their infants and families to improve their pregnancy outcomes and their health, well-being and self-sufficiency. The funds will be used to support the existing contract with Visiting Nurse Service of Rochester and Monroe County, Inc. The funds may also support other program related expenses, including partial funding for existing positions, administrative support, training, printing and supplies. The NYSDOH declared that a separate contract from the current Maternal, Infant and Early Childhood Home Visiting (MIECHV) initiative funding needed to be established for this proposed MIECHV funding. The reason was that even though the funding is from the same source, this more recent award was established through a Request for Proposals and they could not include this in the existing contract. NYSDOH will not be requiring any separate reports or outcomes for the new funding. This is the first year the County has received this grant.

Visiting Nurse Service of Rochester and Monroe County, Inc. provides the nurses who make home visits to all NFP clients and administrative support in arranging for travel, accommodations and training for the program.

A request for qualifications was issued for home visiting nursing services and Visiting Nurse Service of Rochester and Monroe County, Inc. was selected as the most qualified.

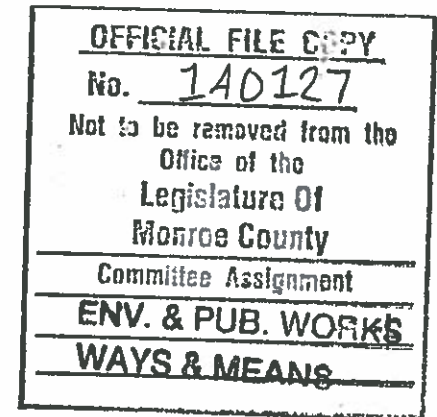

I recommend that Your Honorable Body amend the 2014-2019 Capital Improvement Program and the 2014 Capital Budget, to add a capital project entitled, "Taxiway A Improvements," in the amount of \$2,500,000; authorize financing for the project, in the amount of \$2,500,000; and authorize a contract with CHA Consulting, Inc., in the amount of \$87,000, for design services, for the Taxiway A Improvements project at the Greater Rochester International Airport.

This project is necessary to enhance the operational safety for the air carriers by implementing improvements to Taxiway A between Taxiway A-1 and Taxiway A-2, including the expanded taxiway pavement on the east of Taxiway A referred to as the "Taxiway 'A' Hold Apron." The improvements will include new concrete pavement and localized rehabilitation of existing pavement as recommended in the Airport Pavement Management Update in 2013. The project will also include localized work on the deicing vehicle access road, drainage improvements, pavement markings and electrical work, in order to continue providing appropriate deicing fluid collection at this location as it relates to the Runway 4 end for aircraft takeoffs.

This project will be funded by a Federal Aviation Administration grant of 90%, a New York State Department of Transportation grant of 5%, and a local share of 5%.

I recommend that Your Honorable Body accept a Congestion Mitigation and Air Quality Improvement grant from Genesee Region Clean Communities, in the amount of \$149,806.50, for the implementation of an Alternative Fuel Vehicle Engine Modification Program, for the period of May 1, 2014 through April 30, 2015.

As part of its ongoing commitment to building a world class green vehicle fleet, the Department of Environmental Services will convert fifteen (15) vehicles from using gasoline to propane (LPG) or compressed natural gas (CNG). The grant provides 75% of the cost for this conversion with Monroe County providing the remaining 25%. The estimated payback due to reduced fuel costs is less than three (3) years. In addition, these conversions will reduce greenhouse gas emissions by 10%. This will be the first year the County has received this grant.
