The County Executive, or his designee, is hereby authorized to execute a contract with Bell Construction Corporation, in the amount of \$198,200, for plumbing, for the Monroe County Jail Visitation Renovation Project, and any amendments necessary to complete the project within the total capital fund(appropriation.

The County Executive, or his designee, is hereby authorized to execute a contract wire Kaplan Schmidt Electric, Inc., in the amount of \$1,028,000, for electrical, for the Monroe County Jail Visitation Renovation Project, and any amendments necessary to complete the project within the total capital fund(appropriation.
Section 6. Funding for this project, consistent with authorized uses, is included in capital fund 189 and any capital fund(s) created for the same intended purpose.
