BE IT RESOLVED BY THE LEGISLATURE OF THE COUNTY OF MONROE, as follows:
Section 1. The Monroe County Legislature determines that the acquisition of easements for Taylor Road Bridge Replacement Project in the Town of Mendon is an Unlisted action.
Section 2. 
