Once that was agreed upon President LaMar called for a motion to vote on six (6) meetings with one (1) being zoom only. Legislator Colby MOVED and Ms. Nicolay SECONDED. The vote passed unanimously 5-0.

Discussion then turned towards location of the six (6) meetings. It was agreed upon by all members to have two (2) city, one (1) Eastside, one (1) Westside, and one (1) in a neutral area locations for meeting. The locations of Ogden, Henrietta, East Rochester, David F. Gantt Center, Wilson Foundation Academy, and one (1) strictly zoom meeting was proposed. Legislator Colby MOVED and Ms. Nicolay SECONDED a motion to schedule the public meetings as presented. A vote was taken and was approved 5-0. It was then agreed upon Commissioners will work on dates for next meeting to finalize the times of each meeting.

The Commissioners then proceeded to discuss professional services agreements. Commissioners Nicolay and Ortiz both presented four (4) total different redistricting services offered (see attached). Discussion continued about each leaving the Commissioners in agreement that Commissioners Nicolay and Ortiz would get some more specifics on pricing before next meeting so the Commission could vote and make a selection.
