RESOLUTION NO. ____ OF 2016

MORTGAGE TAX DISTRIBUTION

WHEREAS, in compliance with Section 261 of the Tax Law, the County Clerk and the Director of Finance have filed with the Clerk of the Legislature and the New York State Tax Commission a joint report (File No. 00 ____), showing the total amount of Mortgage Tax allocated to the various tax districts in Monroe County to be \$7,357,672.27 for the period April 1, 2016 through September 30, 2016.

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE COUNTY OF MONROE, as follows:

Section 1. That the Controller be, and he hereby is, authorized and directed to draw checks on the Mortgage Tax Fund and to make payment on or before December 15, 2016 as follows: one to the City of Rochester, Treasurer, in the amount of \$1,173,254.89 and one to the Supervisor of each Town and to the Village Treasurer of each Village pursuant to the Distribution Table, as follows:
