Grant Funds

Honorable Legislators:

I recommend that Your Honorable Body authorize Monroe County to submit a Consolidated Funding Application for Frontier Field (the "Stadium") improvements through Empire State Development Grant Funds and Market New York facility grant funds.

Funds being requested through Empire State Development Grant Funds and Market New York facility grant funds will be used to update the Stadium including structural, mechanical, electrical and cosmetic improvements. Proposed improvements include, but are not limited to structural steel painting, equipment upgrades, replacement of the field, and energy management systems. Estimates for the proposed improvements to the Stadium total \$7.5 million.

The funding request for Empire State Development Grant Funds and Market New York facility grant funds total \$4.5 million toward the \$7.5 million project. The remainder of \$3 million in funding for Monroe County, will be funded through the proposed 2015 - 2020 Capital Improvement Program and support from Rochester Community Baseball.

The specific legislative action required is to authorize the County Executive, or her designee, to submit a Consolidated Funding Application for Frontier Field improvements through Empire State Development Grant Funds and Market New York facility grant funds.

No net county support is required in the current Monroe County budget.

I recommend that this matter be referred to the appropriate committee(s) for favorable action by Your Honorable Body.
