Honorable Legislators:

I recommend that Your Honorable Body amend the 2017 Capital Budget and Bond Resolution 22 of 2017 to provide an increase in funding, in the amount of \$51,000, and authorize a contract with Economy Paving Co., Inc. in the amount of \$966,468.69, for construction services for the Bowerman Road Bridge over Oatka Creek Project in the Town of Wheatland.

This bridge rehabilitation project involves replacement of the existing bridge deck, bridge railing, minor abutment repairs, bearing replacement and structural steel modifications. There are currently insufficient funds available for the project due to more extensive work needed since it was initially programmed in the Capital Improvement Program. The increase results in an additional \$51,000 over the current project budget. The total estimated project cost is now \$1,295,000.

Major funding will be provided from federal and state aid in the amount of approximately 95% of the project cost with overall project administration by Monroe County.

The following five (5) bids were received on December 20, 2016:

The bids have been reviewed and the Department of Transportation recommends the award of the contract to the lowest responsible bidder, Economy Paving Co. Inc. in the amount of \$966,468.69.

The specific legislative actions required are:

- 1. Amend the 2017 Capital Budget to increase the project funding for the Bowerman Road Bridge over Oatka Creek Project in the Town of Wheatland, in the amount of \$51,000, from \$1,244,000 to \$1,295,000, for a total project authorization \$1,295,000.
- 2. Amend Bond Resolution 22 of 2017 to increase financing for the Bowerman Road Bridge over Oatka Creek Project in the Town of Wheatland, capital fund 1743, in the amount of \$51,000, from \$1,244,000 to \$1,295,000, for a total project authorization of \$1,295,000.
- 3. Authorize the County Executive, or her designee, to execute a contract with Economy Paving Co., Inc., 1819 New York State Route 13, Cortland, New York 13045, in the amount of \$966,468.69, for construction services, for the Bowerman Road Bridge over Oatka Creek project in the Town of Wheatland, and any amendments necessary to complete the project within the total capital fund(s) appropriation.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

Funding for this contract, consistent with authorized uses, will be available in capital fund 1743 once the additional financing authorization requested herein is approved and in any capital fund(s) created for the same intended purpose. No additional net County support is required in the current Monroe County budget.

The records in the office of the Monroe County Treasury have indicated that neither Economy Paving Co., Inc., nor its sole principal officer, Stephen J. Campagni, President, owe any delinquent Monroe County property taxes.

Authorize Amendments to the 2017 Capital Budget to Increase Project Authorizations for Various Capital Projects Related to the Dissolution of Local Development Corporations; Provide Funding by Authorizing Appropriation Transfers

Honorable Legislators:

I recommend that Your Honorable Body amend the 2017 capital budget to increase project authorizations for various capital projects related to the dissolution of Upstate Telecommunications Corporation (UTC) and Monroe Security & Safety Systems Local Development Corporation (M3S), and provide funding for the project increases by authorizing the Controller to transfer appropriations from the operating budget to the capital budget.

By Resolution 98 of 2017 and Resolution 99 of 2017, Your Honorable Body accepted the assets and liabilities of UTC and M3S pursuant to an order of dissolution, and amended the 2017 operating budget to provide appropriations for the provision for capital projects. The Department of Finance now seeks authorization to transfer those appropriations from the operating budget to the capital budget, as the capital projects for which those appropriations pertain currently exist within the amended 2017 Capital Improvement Program and 2017 capital budget.

The increase in project authorizations and subsequent transfer of appropriations are necessary to meet the current and near-future capital needs of the Departments of Public Safety, Information Services, and Environmental Services to keep vital communications, security, and office systems on-line and operating at acceptable performance standards.

The specific legislative actions required are:

- 1. Amend the 2017 capital budget to increase funding for the Security Systems Improvement project, in the amount of \$150,000 from \$150,000 to \$300,000, for a total project authorization of \$300,000.
- Authorize the Controller to transfer \$150,000 from the 2017 operating budget of the Department of Environmental Services, internal services fund 9020, funds center 8610010000, Fire Alarm/Security Maintenance, to capital fund 1814 established for the project "Security Systems Improvement."

- 3. Amend the 2017 capital budget to increase funding for the Enterprise Resource Planning / Security project, in the amount of \$750,000 from \$850,000 to \$1,600,000, for a total project authorization of \$1,600,000.
- 4. Authorize the Controller to transfer \$750,000 from the 2017 operating budget of the Department of Information Services, internal services fund 9020, funds center 1902010000, Equipment Lease / Maintenance, to capital fund 1815 established for the project "Enterprise Resource Planning / Security."
- 5. Amend the 2017 capital budget to increase funding for the Network Infrastructure project, in the amount of \$2,250,000 from \$200,000 to \$2,450,000, for a total project authorization of \$2,450,000.
- 6. Authorize the Controller to transfer \$2,250,000 from the 2017 operating budget of the Department of Information Services, internal services fund 9020, funds center 1902010000, Equipment Lease / Maintenance, to capital fund 1816 established for the project "Network Infrastructure."
- 7. Amend the 2017 capital budget to increase funding for the Office Equipment Refresh & Replacement project, in the amount of \$5,500,000 from \$200,000 to \$5,700,000, for a total project authorization of \$5,700,000.
- 8. Authorize the Controller to transfer \$5,500,000 from the 2017 operating budget of the Department of Information Services, internal services fund 9020, funds center 1902010000, Equipment Lease / Maintenance, to capital fund 1817 established for the project "Office Equipment Refresh & Replacement."
- 9. Amend the 2017 capital budget to increase funding for the Public Safety Communications Equipment and Device Replacement project, in the amount of \$5,500,000 from \$965,000 to \$6,465,000, for a total project authorization of \$6,465,000.
