Subject: Authorize a Contract with the Monroe Community Hospital Auxiliary for Resident Transport Vehicle Lease Payment Reimbursement

Honorable Legislators:

I recommend that Your Honorable Body authorize a contract with the Monroe Community Hospital Auxiliary, in an amount not to exceed \$64,727, to reimburse Monroe County for lease payments for a resident transport vehicle, for the period of May 1, 2018 through April 30, 2022.

The New York State Department of Health requires health care facilities ensure that their residents/patients have the right and the ability to participate in activities and to arrange for transportation opportunities in a safe and secure manner for any resident requiring such service. Monroe Community Hospital Auxiliary will provide to the County reimbursement of payments for a four-year lease between Empire Bus Sales, LLC and Monroe County for a resident transport vehicle.

The specific legislative action required is to authorize the County Executive, or her designee, to execute a contract and any amendments thereto, with the Monroe Community Hospital Auxiliary, 435 East Henrietta Road, Rochester, New York 14620, to reimburse Monroe County for lease payments for a resident transport vehicle, in an amount not to exceed \$64,727, for the period of May 1, 2018 through April 30, 2022.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.
