Honorable Legislators:

This matter is being referred to Your Honorable Body at the request of Monroe County Clerk Jamie Romeo.

I recommend that Your Honorable Body certify to the New York State Tax Commission the reasonable and necessary expenses of the County Clerk for the administration of the mortgage recording tax law in her office.

The purpose of the resolution is to allow the County Clerk, as the recording officer in and for the County of Monroe, to receive the annual amount of \$839,869.32 as the expenses of employing clerks and assistants for the administration of the mortgage recording tax law in her office for the period of April 1, 2025 through March 31, 2026. The County Clerk has received this amount for this purpose annually since 2008.

The specific legislative action required is to determine the amount \$839,869.44 to be a reasonable and necessary allowance for the expenses of the recording officer for the County of Monroe for the employment of clerks and assistants in the administration of the mortgage recording tax law in the Monroe County Clerk's office for the period of April 1, 2025 through March 31, 2026, and to certify the same to the New York State Tax Commission.

This is a Type II Action pursuant to 6 NYCRR §617.5(c)(26) ("routine or continuing agency administration and management, not including new programs or major reordering of priorities that may affect the environment") and is not subject to further review under the State Environmental Quality Review Act.

This certification is revenue generating and no net County support is required in the current Monroe County budget.

I recommend that this matter receive favorable action by Your Honorable Body.
