VOTER REGISTRATION

A person may register if he/she is:

- 18 years of age by Election Day (you may pre-register at 16 or 17 but cannot vote until you are 18);
- a United States citizen;
- a resident of Monroe County for thirty days prior to the Election;
- not be in prison for a felony conviction
- not claiming the right to vote elsewhere.
- not found to be incompetent by a court

Any Change of Party Enrollment is effective immediately; except for those filed between Feb 15 – July 2; Change of Enrollments filed between Feb 15 – July 2 will take effect on July 2, 2024

VOTER REGISTRATION FOR STATE/LOCAL PRIMARY

- June 15 **Voter registration for State/Local Primary:** Last day application must be received by board of elections to be eligible to vote in primary election. §5-210, 5-211, 5-212
- June 10 **Changes of address** for State/Local Primary received by this date must be processed. §5-208(3)

VOTER REGISTRATION FOR GENERAL

- Oct 26 **Voter registration for State/Local Primary:** Last day application must be received by board of elections to be eligible to vote in primary election. §5-210, 5-211, 5-212
- Oct 21 **Changes of address** received by this date must be processed. §5-208(3)

- June 25 Last day to postmark Military ballot for State/Local Primary and date it must be received by the Board of Elections is July 4. §10-114(1)

- Nov 5 Last day to postmark General Election ballot. Must be received by the Board of Elections no later than Nov 14. §8-412(1)
- Nov 5 Last day to deliver General Election ballot in person to Board of Elections or your poll site, by close of polls on election day. §8-412(1)

MILITARY VOTING FOR GENERAL ELECTION

- Sept 20 Date to transmit Military General Election ballots. §10-108(1), 11-204(4)
- Oct 26 Last day for the Board of Elections to receive application for a Special Federal absentee ballot if not previously registered. §10-106(5)
- Oct 26 Last day for the Board of Elections to receive application for a Military absentee ballot if not previously registered. §10-106(5)
- Oct 29 Last day for the Board of Elections to receive Military absentee application, if by mail and previously registered. §10-106(5)

REGISTRATION AND ABSENTEE/EARLY VOTE BY MAIL VOTING

REGISTRATION

A person may register if he/she is:

- 18 years of age by Election Day (you may pre-register at 16 or 17 but cannot vote until you are 18)
- a United States citizen
- a resident of Monroe County for thirty days prior to the Election.
- not in prison for a felony conviction
- not claiming the right to vote elsewhere
- not found to be incompetent by a court

VOTER REGISTRATION: You may register at your local Board of Elections or any state agency participating in the National Voter Registration Act, on any business day throughout the year but, to be eligible to vote in the November 5, 2024 General Election, your application must be received no later than October 26.

CHANGE OF ADDRESS: If currently registered, your notice of change of address must be received by the Board of Elections by October 21 to be processed and entered in the records for the General Election.

ABSENTEE/ EARLY VOTE BY MAIL VOTING

A voter is eligible for an absentee ballot in a Primary, Special or General Election if he/she is required to be absent from the County on that day because of duties, occupation, business or vacation or if he/she will be confined by illness on either a temporary or permanent basis. An application for an absentee ballot may be obtained from the Board of Elections.

Early Mail Ballot allows any registered voter to request an Early Mail Ballot. This application can be personally delivered to your county board of elections until the day before the election or by mail until 10 days before the election.

The last day for the Board of Elections to receive an application for an absentee ballot/ Early Mail is October 26. Absentee/ Early Mail ballots for a Primary, General or Special Election, if postmarked no later than the day of the Election, will be accepted if received at the Board of Elections within seven days after the Election. A person whose illness or physical disability commences within ten days prior to Election Day may make signed application to the Board of Elections through **5 P.M.** on the day prior to the Election. A person called out of the county after the deadline for an absentee/ Early Mail application may apply **in person** at the Board of Elections through **5 P.M.** on the day before the Election.
