The “Nuts and Bolts” program in a CLE program that was given in 2011 by the Monroe County Public Defender’s Office and the Monroe County Office of the Conflict Defender. These programs have been videotaped and are available through the Office of the Conflict Defender, as are the written materials for each program. CLE credit is not available for the viewing of these programs on video. Each program is approximately two hours long and is a basic, step by step overview of each topic heading. An equivalent CLE program is also acceptable, providing that the agenda for the CLE is provided to Administrator of the Assigned Counsel Program along with a copy of the Certificate of Attendance.

Panel members must complete a minimum of 24 credits every two years (or 32 hours for attorneys admitted less than two years), **eight (8)** of which must be in the field of law applicable to the panel for which he or she is a member. Should a member be sitting on both criminal and family court panels, then **twelve (12)** of the twenty-four credit hours shall be in criminal and family law, with a minimum of six in each field of law.
