Upcoming Felony Trials

Below, I share the felony jury trials scheduled during the remainder of January. I will continue to keep you updated on the results of these trials.

*The **People vs. David Lee Porter** will continue into next week. This case is being prosecuted by First Assistant District Attorney Perry Duckles.*

The defendant is charged with Murder in the 1st Degree, two counts of Murder in the 2nd Degree, two counts of Attempted Robbery in the 1st Degree, two counts of Robbery in the 1st Degree, Robbery in the 2nd Degree, and two counts Criminal Possession of a Weapon in the 2nd Degree in front of New York State Supreme Court Justice Healy

*The **People vs. Shavar Brooks and Miguel Clemons** will continue into next week.*

This case is being prosecuted by Assistant District Attorney Adam VanHeyst, of the Non-Fatal Shooting Taskforce, and Assistant District Attorney Jonathan Jirik, of the Vehicular Crimes Bureau.

Both defendants are charged with Attempted Murder in the 2nd Degree, Assault in the 1st Degree, and two counts of Criminal Possession of a Weapon in the 2nd Degree in front of Monroe County Court Judge Dollinger.

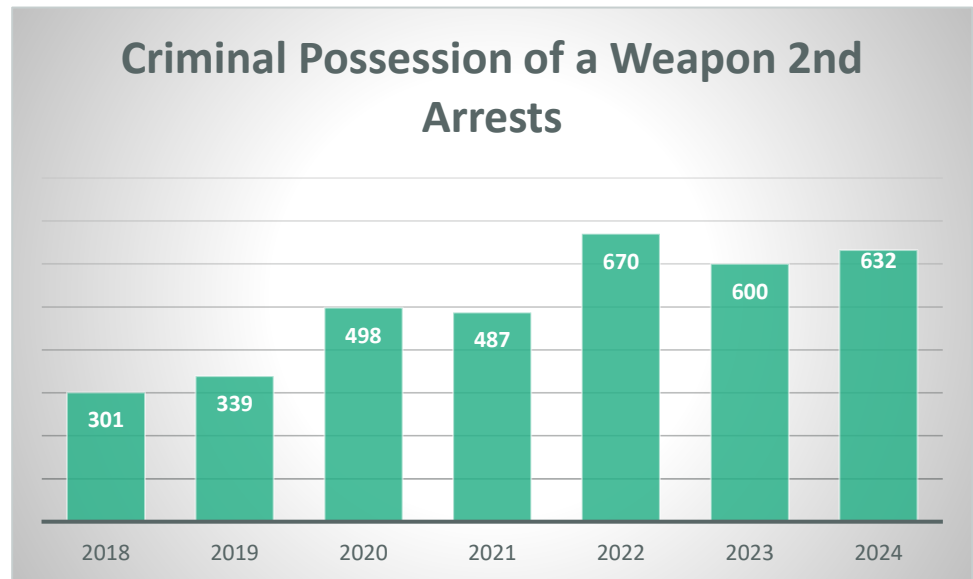

MCDA in the Community

This week, Assistant District Attorneys from the Special Investigations Bureau attended the annual Project Exile Report to the Community. At the luncheon, representatives from agencies provided reports on their accomplishments and difficulties in fighting against gun violence this year.

In the Monroe County District Attorney's Office, we took in 632 Criminal Possession of a Weapon in the 2nd Degree cases.



As you can see above, while this is higher than last year, these numbers are lower than our all-time high in 2022, with 670 cases. However, according to our partners in GIVE, shooting incidents and shooting victims are down over 30% compared to last year. While arrests are up, shooting are down and we are taking more guns off our streets.

Of these 632 cases from 2024, 34%, or 213 of these defendants were predicate felony offenders or were on parole at the time of the arrest. Another 3%, or 16 of these offenders were on probation.

Overall, enforcement is up, arrests are up, and shootings are down. This could be the result from the Monroe County District Attorney's Office collaborative partnership with GIVE. The Non-Fatal Shooting Initiative, which is funded by the State, is also making great strides in our cooperation with victims and witnesses in these often difficult cases.



Highlights from the MCDA's Office

49-year-old **James Spivey, Jr.** was convicted by a Monroe County jury of Robbery in the 1st Degree for the armed robbery of a woman at a laundromat and Robbery in the 3rd Degree for a strong armed robbery of an elderly woman outside a corner store. On January 30, 2023, the defendant threatened the victim with a gun, and forcibly stole property from her in front of her young son. On June 7, 2023 the defendant followed an elderly woman outside a corner store where he forcibly stole money from her. This case was investigated by the Rochester Police Department and prosecuted by Special Assistant District Attorney Aliyah Fowler, of the Major Felony Bureau. James Spivey, Jr. will be sentenced on February 13, 2025, in front of New York State Supreme Court Justice Argento.

54-year-old **Elona Roberts** pled guilty to Grand Larceny in the 4th Degree for stealing over \$121,000 in New York State pension checks sent to her deceased grandmother since 2017. This case was investigated by the New York State Comptroller's Office and the Monroe County Sheriff's Office. This case was prosecuted by Assistant District Attorney Gregory Clark, Chief of the Public Integrity/Economic Crimes Bureau. Elona Roberts will be sentenced in front of New York State Supreme Court Justice Miller on March 7, 2025, and is expected to pay full restitution to the State and be placed on probation.

38-year-old **Tyrone Legree** pled guilty to Course of Sexual Conduct Against a Child in the 1st Degree for acts against a child less than thirteen years old between March 1, 2018 and August 10, 2023. This case was investigated by the Rochester Police Department and prosecuted by Assistant District Attorney Jessica Wagner, of the Special Victims Unit. Tyrone Legree will be sentenced on February 21, 2025, in front of Monroe County Court Judge Morrison.

Sean Magro was indicted on Driving While Ability Impaired by Drugs, Criminal Possession of Stolen Property in the 4th Degree, Aggravated Unlicensed Operation of a Motor Vehicle in the 1st Degree, Unauthorized Use of a Vehicle in the 2nd Degree, Resisting arrest, and Reckless Driving in relation to a vehicular incident on November 13, 2024. This case is being prosecuted by Assistant District Attorney Diane Orosz-Roy of the Vehicular Crimes Bureau.

Salvatore Latone was indicted on Burglary in the 3rd Degree in relation to a burglary at a Home Depot on October 17, 2024. He was also charged with Burglary in the 2nd Degree in a separate indictment in relation to a home burglary on November 18, 2024. These cases are being prosecuted by Assistant District Attorney Angela Carson, of the General Felony Bureau.

Darius Peterson, Davontae Ruffin, and Dameion Schultz were indicted on Robbery in the 1st Degree, Burglary in the 1st Degree, and Robbery in the 2nd Degree in relation to an armed robbery on October 11, 2024. This case is being prosecuted by Assistant District Attorney Matthew Hogestyn, of the Major Felony Bureau.

Alvin Nickson was indicted on Murder in the 2nd Degree and two counts of Criminal Possession of a Weapon in the 2nd Degree in relation to the shooting homicide of Rodney Corbit on September 26, 2024. Michael Richardson was indicted on Assault in the 2nd Degree, Vehicular Assault in the 2nd Degree, and two counts of Driving While Intoxicated in relation to a vehicular assault on December 19, 2024. This case is being prosecuted by Assistant District Attorney Merrick Sadler, of the Non-Fatal Shooting Taskforce and Assistant District Attorney Courtney Kleiman, of the Vehicular Crimes Bureau.
