March Felony Trials

Below, I share the felony jury trials scheduled during the month of March. I will continue to keep you updated on the results of these trials.

The jury is out for **The People vs. Stephen Phillips**.

This case is being prosecuted by Assistant District Attorney Jonathan Jirik, of the Major Felony Bureau.

The defendant is charged with Strangulation in the 2nd Degree in front of New York State Supreme Court Justice Moran.

The People vs. Quintel Crockton will continue into next week.

This case is being prosecuted by Assistant District Attorney Kevin Sunderland, Chief of the Local Courts Bureau.

The defendant is charged with Murder in the 2nd Degree in front of New York State Supreme Court Justice Schiano.

March 3 – People vs. Anthony Johnson

This case is being prosecuted by Assistant District Attorney Michael Caranante, of the Special Investigations Bureau.

The defendant is charged with Criminal Possession of a Weapon in the 2nd Degree in front of Monroe County Court Judge Dollinger.

March 17 – People vs. Shaun Jones

This case is being prosecuted by Assistant District Attorney Aliyah Fowler, of the Major Felony Bureau.

The defendant is charged with Robbery in the 1st Degree, two counts of Criminal Possession of a Weapon in the 2nd Degree, and Criminal Possession of a Weapon in the 3rd Degree in front of New York State Supreme Court Justice Renzi.

March 17 – People vs. Taroy Williams

This case is being prosecuted by Assistant District Attorney Tony DiPerna, of the Special Investigations Bureau.

The defendant is charged with two counts of Criminal Possession of a Controlled Substance in the 3rd Degree and Criminally Using Drug Paraphernalia in the 2nd Degree in front of Monroe County Court Judge Randall.

March 17 – People vs. Denis Kalemi, Sr.

This case is being prosecuted by Assistant District Attorney Mikael Pelkey, of the Vehicular Crimes Bureau.

The defendant is charged with Driving While Intoxicated in front of Monroe County Court Judge Hahn.

March 17 – People vs. Stephan Rodriguez

This case is being prosecuted by Assistant District Attorney Matthew Hogestyn, of the Major Felony Bureau.

The defendant is charged with Criminal Possession of a Weapon in the 2nd Degree in front of Monroe County Court Judge Randall.

March 17 – People vs. Jermaine Taggart

This case is being prosecuted by Assistant District Attorney Ryan Mulcahy, of the Special Investigations Bureau.

The defendant is charged with three counts of Criminal Possession of a Controlled Substance in the 3^{rd} Degree and three counts of Criminally Using Drug Paraphernalia in the 2^{nd} Degree in front of New York State Supreme Court Justice Sinclair.

March 17 – People vs. Jadell Williams

This case is being prosecuted by Assistant District Attorney Stephen Ryck, of the Special Investigations Bureau.

The defendant is charged with Criminal Possession of a Controlled Substance in the 3^{rd} Degree and two counts of Criminally Using Drug Paraphernalia in the 2^{nd} Degree in front of Monroe County Court Judge Randall.

March 18 – People vs. Cesar Soto-Roman

This case is being prosecuted by Assistant District Attorney Ellie Laloudakis, of the Major Felony Bureau.

The defendant is charged with Murder in the 2^{nd} Degree, Criminal Possession of a Weapon in the 2^{nd} Degree, and Criminal Possession of a Weapon of a Firearm in front of New York State Supreme Court Justice Moran.

March 18 – People vs. Jeremiah Mateo

This case is being prosecuted by Assistant District Attorney Emily Chisholm, of the Non-Fatal Shooting Taskforce.

The defendant is charged with three counts of Attempted Murder in the 2^{nd} Degree, two counts of Assault in the 1^{st} Degree, and two counts of Criminal Possession of a Weapon in the 2^{nd} Degree in front Monroe County Court Judge Dollinger.

March 20 - People vs. Michael Willis

This case is being prosecuted by Assistant District Attorney Megan Hausner, Chief of the Local Court Bureau.

The defendant is charged with Murder in the 2^{nd} Degree and two counts of Criminal Possession of a Weapon in the 2^{nd} Degree in front of New York State Supreme Court Justice Dinolfo.

March 24 – People vs. Asia Kwanai Wimbush

This case is being prosecuted by Assistant District Attorney Diane Orosz-Roy, of the Vehicular Crimes Bureau.

The defendant is charged with Driving While Intoxicated in front Monroe County Court Judge Bailey Turner.

March 24 – People vs. Jiacheng Li

This case is being prosecuted by Assistant District Attorney Aaron Rath, of the Special Victims Unit.

The defendant is charged with two counts of two counts of Unlawful Surveillance in the 2nd Degree, Strangulation in the 2nd Degree, two counts of Criminal Obstruction of Breathing or Blood Circulation, and three counts of Assault in the 3rd Degree in front of New York State Supreme Court Justice Renzi.

March 24 - People vs. Markese Bellamy and Kory Wyatt

This case is being prosecuted by Assistant District Attorney Bridget Morgan, of the Special Investigations Bureau.

The defendants are charged with two counts of Criminal Possession of a Weapon in the 2^{nd} Degree and two counts of Criminal Possession of a Controlled Substance in the 3^{rd} Degree. Markese Bellamy is also charged with Escape in the 1^{st} Degree and Criminally Using Drug Paraphernalia in the 2^{nd} Degree. Both defendants are in front of New York State Supreme Court Justice Argento.

March 24 – People vs. Raymere Alexander and Brandon Williams

This case is being prosecuted by Assistant District Attorney Matthew Schiano, of the Major Felony Bureau.

The defendants are charged with Murder in the 2^{nd} Degree and two counts of Criminal Possession of a Weapon in the 2^{nd} Degree in front of New York State Supreme Court Justice Healy.

March 24 – People vs. Herbert Montgomery

This case is being prosecuted by Assistant District Attorney Patrick Gallagher, Chief of the Domestic Violence Bureau.

The defendant is charged with Murder in the 2nd Degree in front of Monroe County Court Judge Dollinger.

March 24 - People vs. Jamar Graham

This case is being prosecuted by Assistant District Attorney Hillary Langdon, of the Special Victims Unit.

The defendant is charged with seven counts of Predatory Sexual Assault, Kidnapping in the 1st Degree, and Criminal Obstruction of Breathing or Blood Circulation in front of Monroe County Court Judge Hahn.

March 24 - People vs. Edwin Santiago

This case is being prosecuted by Assistant District Attorney Nicholas Reeder, of the General Felony Bureau

The defendant is charged with Burglary in the 3rd Degree in front of New York State Supreme Court Justice Argento.

March 25 - People vs. Levonte Smith

This case is being prosecuted by Assistant District Attorney Stephen Ryck, of the Special Investigations Bureau.

The defendant is charged with Criminal Possession of a Weapon in the 2nd Degree in front of New York State Supreme Court Justice Miller.

March 31 – People vs. Frederick Blocker

This case is being prosecuted by Assistant District Attorney Aliyah Fowler, of the Major Felony.

The defendant is charged with Robbery in the 1st Degree and Robbery in the 2nd Degree in front of New York State Supreme Court Justice Schiano.

March 31 – People vs. Devonta Hayes

This case is being prosecuted by Assistant District Attorney Jennifer Kennedy, Deputy Chief of the Special Investigations Bureau.

The defendant is charged with Criminal Possession of a Controlled Substance in the 3^{rd} Degree, Criminal Possession of a Controlled Substance in the 4^{th} Degree, and Criminally Using Drug Paraphernalia in the 2^{nd} Degree in front of New York State Supreme Court Justice Schiano.

March 31 – People vs. Walter Balkum, Jr.

This case is being prosecuted by Assistant District Attorney Kaylee Rizzari, of the Special Victims Unit.

The defendant is charged with Manslaughter in the 1st Degree, Aggravated Criminal Contempt, and two counts of Assault in the 2nd Degree in front of New York State Supreme Court Justice Renzi.

March 31 – People vs. Raquintis Tisdale

This case is being prosecuted by Assistant District Attorney Stephen Ryck, of the Special Investigations Bureau.

The defendant is charged with Criminal Possession of a Weapon in the 2nd Degree and Criminal Possession of a Weapon in the 3rd Degree in front of Monroe County Court Judge Ansaldi.

March 31 – People vs. Lloyd Kennedy, Jr.

This case is being prosecuted by Assistant District Attorney Bridget Morgan, of the Special Investigations Bureau and Assistant District Attorney Angela Carson, of the General Felony Bureau.

The defendant is charged with two counts of Criminal Possession of a Weapon in the 2^{nd} Degree, Criminal Possession of a Weapon in the 3^{rd} Degree, and Menacing in the 2^{nd} Degree in front of New York State Supreme Court Justice Sinclair.

March 31 – People vs. Sulamain Hawkins and Anastasia Weaver

This case is being prosecuted by Assistant District Attorney Sara VanStrydonck, Chief of the Special Victims Unit.

The defendants are charged with Manslaughter in the 2nd Degree in front of New York State Supreme Court Justice Argento.

March 31 - People vs. Tyrone Morris

This case is being prosecuted by Assistant District Attorney Nicholas Reeder, of the General Felony Bureau.

The defendant is charged with Criminal Possession of Stolen Property in the 2nd Degree in front of New York State Supreme Court Justice Argento.

A 2017 Gates Chili High School graduate, Officer Girvin valiantly served his community in Virginia Beach since 2020. On February 22, Officer Girvin, and Virginia Beach Police Officer Christopher Reese, were killed in the line of duty during a traffic stop last week.

Highlights from the MCDA's Office

42-year-old **Sarah Samsel** was convicted by a jury of Robbery in the 1st Degree and Kidnapping in the 2nd Degree. On January 21, 2023, Sarah Samsel, and codefendant Luther Brown restrained a victim inside a house at gunpoint. While held captive, Sarah Samsel withdrew money out of the victim's bank account. Luther Brown previously pled guilty to Attempted Robbery in the 1st Degree and was sentenced to 7 years in the New York State Department of Corrections plus 5 years of post-release supervision. This was case was investigated by the Rochester Police Department and prosecuted by Assistant District Attorney Ellie Laloudakis, of the Major Felony Bureau. Sarah Samsel will be sentenced on May 9, 2025, in front of Monroe County Court Judge Hahn.

31-year-old **Randell Parris** was convicted by a jury of Criminal Possession of a Weapon in the 2nd Degree for the illegal possession of a firearm on October 30, 2023. This case was investigated by the Rochester Police Department and prosecuted by Assistant District Attorney Stephen Ryck, of the Special Investigations Bureau. He will be sentenced by New York State Supreme Court Justice Argento on April 10, 2025.

40-year-old **Richie Johnson** pled guilty to Criminal Sexual Act in the 1st Degree for the sexual assault of a woman on September 11, 2023. This case was investigated by the Rochester Police Department and prosecuted by Assistant District Attorney Jessica Wagner, of the Special Victims Unit. Richie Johnson will be sentenced on April 3, 2025, in front of Acting Monroe County Court Judge Patterson.

42-year-old **Markie Johnson** was convicted by a jury of Driving While Ability Impaired. On March 13, 2024, the defendant was pulled by the New York State Police for operating a cell phone while driving. He was determined to be under the influence of alcohol. This case was prosecuted by Assistant District Attorney Courtney Kleiman, of the Vehicular Crimes Bureau. Markie Johnson was sentenced in front of Monroe County Court Judge Ansaldi.
