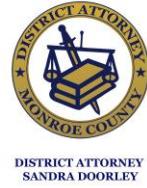

Upcoming Felony Trials

August 19 – People vs. Whittmore Cunningham, Jr.

This case is being prosecuted by Assistant District Attorney Aaron Rath, of the Special Victims Unit.

The defendant is charged with Strangulation in the 2nd Degree, Assault in the 3rd Degree, Criminal Mischief in the 4th Degree, and Criminal Obstruction of Breathing or Blood Circulation in front of Monroe County Court Judge Morrison.

Indictment Unsealed Charging Former City of Rochester Employee Anthony Hall with Grand Larceny in the 3rd Degree

A Monroe County Grand Jury indictment was unsealed in front of Monroe County Court Judge Morrison, charging 38-year-old Anthony Hall with one count of Grand Larceny in the 3rd Degree (Class D Felony) in violation of Penal Law Section 155.35 (1).

This charge alleges that Anthony Hall stole property which belonged to Coalition of North East Associations, Inc., the value of which exceeded \$3,000. This charge is alleged to have occurred on or about and between December 1, 2018 and September 3, 2019.

Anthony Hall was arrested on Tuesday, August 13, 2024. This case was investigated by the New York State Police and the Monroe County District Attorney's Office.

The case is being prosecuted by Assistant District Attorney Karina Pinch, of the Public Integrity/Economic Crimes Bureau, and Assistant District Attorney Caroline Rodriguez, also of the Public Integrity/Economic Crimes Bureau.

The next court date is scheduled for October 7, 2024 at 9:30AM before New York State Supreme Court Justice Moran.
