RE: Memorializing the United States Congress to Pass the LGBTQI+ and Women's History Education Act of 2023.

Honorable Legislators:

Between 2021 and 2023, nine states passed censorship laws restricting schools from including influential and historical members of the LGBTQI+ community in the curriculum. According to the ACLU, over 200 anti-LGBTQI+ school and education bills were introduced in 2023 in State legislatures across the Country.

Erasing LGBTQI+ individuals from education is unacceptable. Children in these schools will now never learn of the achievements of Sally Ride, Frida Kahlo, Angela Davis, and countless other important historical figures. They will never learn of the Stonewall Riots or of Marsha "Pay it No Mind" Johnson.

This bill, H.R.4273, sponsored by Representative Becca Balint, calls for the National Museum of American History of the Smithsonian Institution to develop and distribute relevant, accurate, and accessible resources for teachers to use to include LCBTQI+ and women's history in their curriculum. Further, the bill emphasizes an inclusive and intersectional method of teaching and includes workshops to help educators incorporate this approach in their classrooms.

Further, this legislation would see the creation of a Smithsonian website dedicated to improving awareness and understanding of LGBTQI+ and women's history education. So that even in states with harmful anti-LGBTQI+ education laws, students can still access credible information online.

H.R.4273: LGBTQI+ and Women's History Education Act of 2023 is imperative to ensuring the incredible work of LGBTQI+ individuals and women does not disappear from our history. We encourage the members of the House of Representatives to pass this legislation, and for members of the Senate to introduce a companion bill. We also urge President Biden to follow suit and sign this into law.

#### Honorable Legislators:

The New York State Legislature has passed a bipartisan bill entitled "Removes the Requirement that a Veteran Served During Wartime to be Granted Certain Benefits." This bill reflects an ongoing commitment to recognize and honor all veterans who have served in the armed forces, regardless of the specific time periods of their service. Veterans often face significant challenges when trying to access state services and benefits due to restrictive eligibility criteria based on service periods.

The Vehicle and Traffic Law will extend the provision of distinctive vehicle registration plates for severely disabled veterans to include all veterans who meet the disability criteria, eliminating the previous wartime service requirement.

These changes collectively uphold the principle of fairness and respect, affirming that all veterans, regardless of their service during war or peace, have earned the right to be recognized and supported by the state for their dedication and sacrifices. This legislation is a beacon of fairness in the provision of veterans' benefits, acknowledging that all service, whether in times of conflict or peace, contributes significantly to the safety and security of our nation.

The State of New York has a proud tradition of leading in supporting and advocating veterans' rights and services. This legislation continues that legacy by ensuring no veteran is left behind. This act represents a significant step forward in the comprehensive support of veterans

and their families, ensuring they have access to the educational, medical, employment, and other benefits they rightfully deserve. It is also a matter of effective governance and fiscal responsibility, as it reduces administrative burdens and ensures a more inclusive and fair distribution of resources.

Therefore, we urge you to join us in calling upon Governor Kathy Hochul to sign Bill S.5195-B/A.4611-B into law, ensuring that all veterans, regardless of their service period, are able to receive equal benefits. We urge all legislators to join us in this important effort to honor our veterans, uphold our values of fairness and equity, and continue New York State's leadership in veteran support.



Subject: Memorializing the New York State Legislature to Enact A03022, Prohibits

Price Gouging on Certain Consumer Goods Sold at Thruway Gas Stations,

Restaurants, and Other Facilities

#### Honorable Legislators:

Throughout New York State, drivers, commercial vehicles, and commuters all find themselves navigating the New York State Thruway System at some point or another to travel and work. Due to increasing costs and inflation, driven by policy decisions, current events, and the aftermath of the COVID-19 pandemic, Thruway-goers are forced to pay more out of pocket to travel. Notably, in 2021, tolls were increased by 9% for non-NY E-ZPass vehicles, and by a stark 24% for all Tolls by Mail vehicles. Making the local burden of these higher tolls and costs worse, according to the New York State Thruway System, the Rochester/Victor/Canandaigua Area accounted for the second-highest amount of vehicles traveling on the Thruway per year. In 2022, the mainline section of the Thruway in our area accounted for 21.2 million vehicles annually. While tolls have increased along the Thruway, prices have also surged for consumer goods in the various facilities along the Interstate such as restaurants and gas stations.

During these stressful times of record-high inflation, uncertainty, and fearfulness, price gouging has become prevalent throughout the State and the Nation. Price gouging is defined as the unconscionably excessive pricing of necessary consumer goods and services during times of abnormal market disruption, including but not limited to consumer goods, medical supplies, food, and gasoline. Throughout the COVID-19 pandemic, New York State residents experienced a vast increase in price gouging occurring on behalf of businesses and corporations, leading to out-of-control pricing and unfair business practices. The businesses and corporations with facilities along the New York State Thruway System have also taken part in this, especially given that Thruway-goers are funneled into purchasing fuel, food, and other goods from businesses on the Thruway with no other option.

In order to successfully put an end to the strain that these unfair business practices have placed onto our residents, Assemblyman Jensen introduced Bill A03022, amending the current general business law to prohibit price gouging on certain consumer goods sold within the Thruway facilities. While New York State's general business law prohibits price gouging, it neglected the

Thruway system and its usage of public authorities throughout the Thruway facilities. Bill A03022 remedies this problem by amending the text to read: "This prohibition shall also apply to consumer goods and services sold at service facilities established pursuant to subdivision ten of section three hundred fifty-four of the public authorities law." With ever-increasing tolls, gas prices, and other items, our New Yorkers deserve to know that the prices paid at these facilities are fair and just, without being taken advantage of due to the limited options for goods, services, and fuel along the Thruway system.

Therefore, we, members of the Ways and Means and Transportation Committees, urge you to join us in calling upon the New York State Legislature to pass A.03022 and enact this much-needed change to the general business law in order to better protect our residents and visitors from price gouging on the New York State Thruway System.

#### Honorable Legislators:

I recommend that Your Honorable Body amend the 2024-2029 Capital Improvement Program and 2024 Capital Budget to add a project entitled "Monroe Community College Optics Micro-credential Laboratory;" authorize financing for the project in the amount of \$2,700,000; and authorize contracts with the Dormitory Authority of the State of New York.

The Monroe Community College ("MCC") Optics Project is currently underway to construct new academic spaces in conjunction with the new building for the Applied Technologies Center ("ATC"). Your Honorable Body approved that project by Resolution 402 of 2023. MCC has identified an opportunity to expand the Optics Program through the renovation of existing academic spaces to create Optics Microcredential Laboratories. Micro-credentials are 12-credit "fast track" training programs validated by SUNY that can provide a participant with employer-essential skills in a 15-week timeframe. The dedicated laboratories will allow MCC to efficiently facilitate cohorts of 12 students and serve incumbent workers wanting to upskill, without having to negotiate lab and equipment time around those students seeking Associate degrees and certificates.

This project will relocate non-Optics labs and install new optics training equipment in renovated spaces in Building 9 at the Brighton Campus. The project will be adjacent to, and sequence with, the pending new construction of the ATC/Optics building. The renovations and availability of the space is anticipated for the Fall 2025 semester.

Partial reimbursement of 50% of project costs will be requested from New York State Empire State Development upon establishment of the Resolution and the capital fund.

The project is scheduled to be considered by the Monroe County Planning Board on June 27, 2024.

#### The specific legislative actions required are:

1. Amend the 2024-2029 Capital Improvement Program to add a project entitled "Monroe Community College Optics Micro-credential Laboratory" in the amount of \$2,700,000.

#### Honorable Legislators:

I recommend that Your Honorable Body accept a Restore New York grant from the Empire State Development Corporation in the amount of \$3,000,000 for the Triangle Building Project and enter into a grant agreement, and any accompanying grant documents, with Jays Acquisitions II LLC, or a subsidiary thereof to pass through grant funds up to the amount of \$3,000,000.

The purpose of this grant is to provide funding for a portion of the Triangle Building Project, which includes renovation of 39,000 sq. ft. of the Sibley Triangle Building into 36 residential apartments and 11,500 sq. ft. of lower floor commercial space on the .18 acre site located at 20-30 East Avenue in the City of Rochester. The remaining project costs of \$3,725,000 will be funded through equity and financing from the developer, Jays Acquisitions II LLC.

#### The specific legislative actions required are:

- 1. Authorize the County Executive, or his designee, to accept a \$3,000,000 Restore New York grant from, and to execute a contract and any amendments thereto with, Empire State Development Corporation for the Triangle Building Project.
- 2. Authorize the County Executive, or his designee, to enter into a grant agreement and any accompanying grant documents, and any amendments thereto, with Jays Acquisitions II LLC, or a subsidiary thereof, to utilize grant funds to reimburse for Triangle Building Project cost up to the amount of \$3,000,000.
- 3. Amend the 2024 operating budget of the Department of Planning and Development by appropriating the sum of \$3,000,000 into general fund 9300, funds center 1401010000, Planning Administration.

- 4. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, to make any necessary funding modifications within the grant guidelines to meet contractual commitments, and to enter into any amendments to extend the time period of the grant.
- 5. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law and, when applicable, the terms of any labor agreement affecting such positions.

Honorable Legislators:

Article 25AA Section 303-B of the NYS Agriculture and Markets law allows additions to established agricultural districts prior to the normal eight-year review date. The law also requires the county agricultural and farmland protection board to review the proposed additions to the district(s) and make recommendations on the proposal to the legislative body. Resolution number 10 of 2024 adopted by Your Honorable Body directed the Agricultural and Farmland Protection Board to review and make recommendations on additions to the district(s).

Therefore, in accordance with Article 25AA, we are pleased to transmit this report concerning our review, findings, and recommendations. This report includes 1) a list of six (6) parcels from four (4) landowners. All applicants were interviewed by phone. A determination was made by the AFPB based on soil type, enterprise budget, physical structures and landowner intent as to whether or not these parcels are predominantly viable agricultural land. The following 6 parcels have been found to be viable agricultural land and are recommended by AFPB to be added to an agricultural district.

- Western Agricultural District #5: mailing address Stephen C. Trombley, 1298 West Avenue, Hilton NY, one parcel located in Town of Parma, 023.04-1-12.1 (20.44 acres)
- 2) Western Agricultural District #5: mailing address Anthony C. Zamiara, 5 Stag Creek Trail, Brockport NY, two parcels located in Town of Hamlin, 023.03-2-2.3 (5 acres) and 023.03-2-3.24 (5 acres)

- 3) Western Agricultural District #5: mailing address Nancy S. and Kris M. Sanger, 2845 Colby Street, Brockport NY, two parcels Town of Sweden 099.01-1-15 (9.9 acres) and 099.01-1-13.2 (8.67 acres).
- 4) Eastern Agricultural District #6: mailing address Lynn Keenan, 12 Sisson Drive, Henrietta NY, one parcel Town of Henrietta 189.02-1-7.21 (6.03 acres)

Based on telephone interviews with owners and municipal officials, analysis of USDA soil maps, and site visits, the Board has determined that all 6 parcels are comprised of predominantly viable agricultural land and inclusion of these parcels into an agricultural district would serve the public interest by assisting in maintaining a viable agricultural industry within the respective municipalities.

I recommend that Your Honorable Body authorize an intermunicipal agreement with the Town of Pittsford (the "Town") for the Tobey Road Sidewalk Project in an amount not to exceed \$203,000; appropriate committed fund balance; and authorize an interfund transfer.

The Town has submitted a Monroe County Municipal Sidewalk Funding Application to install approximately 4,435 linear feet of sidewalk along the north side of Tobey Road between Clover Street and Cricket Hill Drive (the "Project"). The total construction costs are anticipated to be approximately \$405,000. Through the intermunicipal agreement, the County will reimburse the Town in an amount not to exceed \$203,000 for construction expenses. The \$203,000 of the County's share will be paid for by the appropriation and transfer of committed fund balance pursuant to Resolution 197 of 2023.

The Project will connect existing sidewalk networks serving this area and provide a continuous path between residential neighborhoods, schools, the YMCA, Tobey Office Park, and the Village of Pittsford. The aforementioned project was identified as a high priority in the Town's and Village of Pittsford's 2019 Active Transportation Plan, and would further the goals of the County's Countywide Active Transportation Plan to fill gaps within the existing sidewalk network.

**Grant Program** 

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the New York State Division of Homeland Security and Emergency Services in the amount of \$126,338 for the FY2021 Technical Rescue & Urban Search and Rescue Grant Program for the period of April 1, 2024 through August 31, 2025.

The New York State Division of Homeland Security and Emergency Services provides funding to support the continued development of the community's technical rescue capabilities. The intent of this grant is to promote regional partnerships using local agency support for technical rescue field response and operations. This program directly supports the on-going activities of the Monroe County Special Operations Unit and its regional partners

Specifically, this grant will enhance the ability to respond to technical rescue incidents in the areas of structural collapse, rope rescue, and related low-frequency/high risk events. This is the eleventh year the County has received the grant. This funding represents a decrease of \$4,600 from the previous grant.

## The specific legislative actions required are:

- 1. Authorize the County Executive, or his designee, to accept a \$126,338 grant from, and to execute a contract and any amendments thereto with, the New York State Division of Homeland Security and Emergency Services for the FY2021 Technical Rescue & Urban Search and Rescue Grant Program for the period of April 1, 2024 through August 31, 2025.
- 2. Amend the 2024 operating budget of the Department of Public Safety by appropriating the sum of \$126,338 into general fund 9300, funds center 2408020100, Mutual Aid Fire Bureau.

- 3. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, to make any necessary funding modifications within the grant guidelines to meet contractual commitments, and to enter into any amendments to extend the time period of the grant.
- 4. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law and, when applicable, the terms of any labor agreement affecting such positions.

This is a Type II Action pursuant to 6 NYCRR §617.5(c)(26) ("routine or continuing agency administration and management, not including new programs or major reordering of priorities that may affect the environment") and is not subject to further review under the State Environmental Quality Review Act.

This grant is 100% funded by the Federal Department of Homeland Security (administered by the New York State Division of Homeland Security and Emergency Services). No net County support is required in the current Monroe County Budget.

Subject: Amend Resolution 234 of 2023 to Amend and Increase the Contract with Ontario Bus Inc. for Bus Transportation Services for Monroe County Early Intervention and Preschool Special Education Programs

## Honorable Legislators:

I recommend that Your Honorable Body amend Resolution 234 of 2023 to amend and increase the contract with Ontario Bus Inc. for bus transportation services for children enrolled in the Monroe County Early Intervention and Preschool Special Education Programs for the period of July 1, 2023 through June 30, 2026, for the first year of the contract (July 1, 2023 through June 30, 2024), with annual increases not to exceed the annual Consumer Price Index ("CPI") increase for the Northeast Urban area for the prior twelve months preceding the date on which the new contract year is to commence, and with the option to renew for two (2) additional one-year periods at an annual rate of increase not to exceed the annual CPI increase for the Northeast Urban area for the twelve months preceding each renewal.

This contract will provide New York State-mandated transportation services to children within Monroe County who are receiving services through our Early Intervention and Preschool Special Education Programs. Children within these programs receive a variety of services, including but not limited to speech therapy, occupational therapy, and physical therapy, which often require transportation to and from the child's home. Ontario Bus Inc. has a history of successfully providing such services to this specialized population.

The specific legislative action required is to amend Resolution 234 of 2023 to amend and increase the contract with Ontario Bus Inc. for bus transportation services for the Monroe County Early Intervention and Preschool Special Education Programs from an amount not to exceed \$10,306,272 to an amount not to exceed \$15,800,000 for the first year of the contract (July 1, 2023 through June 30, 2024).

This action is a Type II Action pursuant to 6 NYCRR § 617.5(c)(26) ("routine or continuing agency administration and management, not including new programs or major reordering of priorities that may affect the environment") and is not subject to further review under the State Environmental Quality Review Act.

Funding for this contract is included in the 2024 operating budget of the Department of Public Health, general fund 9001, funds centers 5807060000, EI Transportation and 5807540000, PSE Transportation, and will be requested in future years' budgets. No additional net County support is required in the current Monroe County budget.

The records in the Office of the Monroe County Treasury have indicated that neither Ontario Bus Inc., nor any of its principal officers, owe any delinquent Monroe County property taxes. The principal officers of the firm are:
